# AMENDMENT # 1 TO THE INTER-LOCAL AGREEMENT DATED FEBRUARY 1, 2005 WITH THE SCHOOL BOARD OF PALM BEACH COUNTY FOR CONSTRUCTION OF MANATEE ELEMENTARY SCHOOL PARKING LOT

THIS AMENDMENT is made to the Inter-local Agreement (R2005-0194) dated February 1, 2005 with the SCHOOL BOARD OF PALM BEACH COUNTY, an independent Board of the State of Florida, hereinafter "BOARD", and the BOARD OF COUNTY COMMISSINERS OF PALM BEACH COUNTY, a political subdivision of the State of Florida, hereinafter "COUNTY".

#### WITNESSETH

WHEREAS, on February 1, 2005, the BOARD and the COUNTY entered into an Inter-local Agreement (R2005-0194) providing for COUNTY funding of BOARD construction of a parking lot for the Manatee Elementary School in an amount not to exceed FIFTY THOUSAND DOLLARS (\$50,000.00) and;

WHEREAS, on February 1, 2005, the COUNTY provided for funding of the construction with the BOARD that provided a completion date of September 30, 2006; and

WHEREAS, the completion date of the project has been delayed due to construction delays with the parking lot; and

WHEREAS, the COUNTY and BOARD desire that this Amendment shall relate back to February 1, 2005, and the contract continued without interruption nor lapse and its term extended until September 30, 2007; and

**NOW, THEREFORE,** in consideration of mutual covenants, promises, and agreements herein contained, the parties agree as follows:

 The Inter-local Agreement dated February 1, 2005, by and between the COUNTY and BOARD shall be continued, without interruption nor lapse in its term or effect commencing February 1, 2005 and expiring September 30, 2007. Accordingly, the Agreement is hereby amended to revise section 9, paragraph 1 as follows:

## Page 3 of 7

9. All installation of the improvement shall be completed and final invoices submitted to the **COUNTY** no later than September

30, 2007, and the **COUNTY** shall have no obligation to the **BOARD** or any other entity or person for any cost incurred thereafter unless the time for completion is extended by modification of this Agreement.

2. It is the intent of the parties hereto that this Amendment shall not become binding until the date executed by the Board of County Commissioners of Palm Beach County.

3. All other provisions of the Inter-local Agreement dated February 1, 2005 shall remain in full force and effect.
