#### Free and Reduced Priced Lunch Benefit Application Distribution

On July 3, 2013 the District released bulletin P-14626/COO/SFS stating that we will not be providing paper applications to every student this year. We will be providing the SFS managers with enough paper applications based on each school's population to be available upon request. This was based on guidance from the state due to the success of our online application process. We are asking that schools continue to encourage the use of the online application system since we are able to provide better and more efficient customer service when an online application is completed. The online application system is available in English, Spanish and Creole. It is suggested that schools allow parents to use the media center to complete applications and/or use the POS terminals in the cafeteria during student orientations and open houses.

In order to remain in compliance this school year with federal guidelines we do need to distribute a letter to each student regarding the application process. Letters are being ponied to your school for inclusion in the students' welcome back packets. Thank you in advance for your assistance with this regulation.

## DID YOU KNOW...

Each SFS Manager will be provided with an acrylic frame containing a poster and business cards to communicate our online application website address to parents and students. We would like to request that this frame be placed in the school's front office in a location easily accessible to parents.

- Student Lunch Status Confidentiality / Permission to Release At the direction of the Florida Department of Agriculture and Consumer Services, and in accordance with guidelines of the National School Lunch Program, all student lunch status information has been removed from EDW. The lunch status of students whose parent/guardian has authorized its disclosure will still be available from your SFS Manager. To make this list more comprehensive, we have provided your SFS Manager with a document entitled Permission to Release. This document can be used by teachers for field trips, by guidance counselors for ESE testing, by secondary schools for test and college application fee waivers. It is suggested that this document become part of the new student registration packet, and that some be kept in the front office, guidance office, student services, and teachers' classrooms so that it can be readily accessed when needed. A copy of the document is attached. If parents complete the document their meal status may be shared with others in the District to receive eligibility in other programs.
- We have provided all SFS staff with "Kids First" T-shirts to be utilized as part of their uniform this school year. The T-shirts are intended to be worn on Fridays or on any spirit days promoted by your school. The school's spirit day shirts may also be worn on Fridays.
- > Lunch meal service times must be within the hours of 10:00 a.m. to 2:00 p.m. in order to remain in compliance with the United States Department of Agriculture (USDA). Please work with the SFS Manager if you have any unusual situations where meal service might occur outside the allowed timeframe and we will request a waiver from the State.

- To ensure that each employee has received proper training and that the SFS Department remains in compliance with all federal, state and local policies and procedures, and to continue to meet our mission, we will be providing a number of mandatory trainings throughout the 2013-2014 school year.
