SUBJECT: SCHOOL BASED TEAM LEADER ASSIGNMENT AND TRAINING - SY 2013

The Department of Safe Schools, in collaboration with the Department of Exceptional Student Education and the Division of Curriculum, offers assistance and support to school centers on the School Based Team (SBT) and Multi-Tiered System of Supports (MTSS) development and process.

The SBT is a District-mandated problem-solving team designed to assist students, families, and teachers beyond core academic and behavioral needs. The Team continues to be the single point of access for identifying, assisting, and referring students with academic, behavioral, social and emotional, and/or attendance issues that negatively impact their academic achievement. In addition, the SBT monitors the needs of homeless and foster care students.

The responsibilities of the SBT Leader include:

- · chairing the weekly or bi-weekly meetings;
- · coordinating and overseeing intervention plan development;
- · reviewing TERMS and Educational Data Warehouse (EDW) reports with the Team;
- student progress monitoring;
- · maintaining SBT student files; and
- ensuring parents and guardians are notified.

Your SBT Leader must also ensure that the SBT Tracking Report (PBSD 2107) is completed and updated regularly in TERMS. A copy of the Tracking Report should be maintained and stored with SBT files. Please assign the data processor or other designee to enter SBT referral, student intervention data, and case tracking into the TERMS L24 and D19 screens using the SBT Tracking Report (PBSD 2107). Each quarter, a report will be completed and provided to Area Superintendents on SBT referrals, student interventions plans and opened and closed cases.

School Based Team Leaders are encouraged to conduct a faculty presentation to explain SBT referral and documentation, intervention process, Response to Intervention (RtI), and community resources available to assist students and families. Furthermore, the Department of Safe Schools will offer monthly trainings and updates for the SBT Leaders and other school-based administrators. Training locations vary to accommodate as many participants as possible.
