<u>Steve B.</u> We want to highlight the Survey Summary for FY 2011-2012. There were very simple questions asked.

- 1. How satisfied are you with the efforts of the Wellness Promotion Task Force?
  - 88% were Very Satisfied
  - 9.6% were Somewhat Satisfied
  - 0% were Neutral
  - 2.4% were Very Dissatisfied
- 2. Why did you attend the Wellness Promotion Task Force meeting?
  - 3.7% attended for the purpose of Networking
  - 3% attended because of Interest in Event Topics
  - 21% attended to Support the Wellness Initiatives
  - 72.3% attended for All the above reasons
- 3. Was this meeting meaningful and valuable to you?
  - 99% stated Yes
  - 1% stated No

has a long established relationship with the Town of Jupiter and the Palm Beach County Health Department. Most recently we have partnered with the Jupiter Medical Center, the Florida Public Health Institute and The School District of Palm Beach County in a new effort to participate in the **Roadmaps to Health** program. This is part of the county health rankings and we first found out about the **Roadmaps to Health** program earlier this year — when it was already late to apply for the 2012 "Prize". El Sol is the ultimate grassroots effort funded by grant money, volunteers, and personal donors. What attracted us to the **Roadmaps to Health** is that it looked at a way to bring together other organizations to improve the overall health of the community. We were proud to be able to open the **Jupiter Volunteer Clinic** starting in February 2012. It is an attempt to reach out to uninsured or underinsured individuals in the northern part of the county. The clinic is staffed by volunteer physicians and nurses from the community. It is located in the Palm Beach County Health Department building at 6405 Indiantown Road and is open on every Saturday. *Any questions?...* 

<u>Jane W.</u> Afterschool Site Director at Beacon Cove Intermediate — We are pleased to be a partner of El Sol and our students have been making stockings as donations and collecting food for Christmas.

**Lynn H.** El Sol has a Family Literacy program which is taught by retired teachers. We have at least one Health Fair per year with services provided by the Jupiter Medical Center, the American Diabetes Association and the American Heart Association.

<u>Ann F.</u> My organization would like to participate in your Health Fair – we provide information and education for people with cancer and *Natural Strategies to Reduce Cancer Risk* for everyone else. It is called the *Annie Appleseed Project* and the number to call is (561) 749-0084.

Paula T. Thank you Lynn.

I am delighted to introduce Lori Dornbusch – Assistant Director, Site Based Operations, School Food Service (SFS) Department.

**Lori D.** Good morning...unfortunately the affect on poor health and poor nutrition have on learning are often not incorporated in the efforts to improve education in the system. Key problems in education such as drop-out or school failure are rarely examined in terms of health and nutritional status of children. Under the USDA's National School Lunch Program (NSLP) household income determines the status of children. If children are eligible for Free and Reduced meals it all leads back to the family income. The household income must be at or below 130% of the Federal Poverty Level. Those with incomes between 130% and 185% of the poverty level are eligible for reduced-price meals. Children in households collecting food stamps are eligible for free lunch at the start. Although the USDA's School Breakfast Program (SBP) is an entitlement program with funds coming from the Federal government with a small subsidy from the State government. Breakfast is not accessible to many children who need it and we wanted to change that in The School District of Palm Beach County. Why did we choose breakfast to make the impact? Information found on the Food Bank's website stated that in Palm Beach County in the most recent food insecurity survey conducted that one in three households with income of less than \$35,000 ran out of food before they had money to buy more. During a door to door survey of households with children stated that 20% of the households cut the size of the children's meals because there was not enough money to buy

more food. Studies show that hungry children arriving at school have less energy available and cannot learn. Every day children go without a meal or two and we always think that those are the poor children. However, in these hard times it is not easy to know who is having difficulty. A nutritionally sound breakfast is a key component in a child's ability to learn – therefore; our SFS Department concentrated efforts to spotlight healthy eating at both breakfast and lunch. For the past 7 years our district has been working to qualify schools to participate in the 100% Accessible Breakfast Program that would allow students to receive a free breakfast regardless of their economic status. We first began researching the possibility of this in FY 2004-2005 by starting with one pilot school to identify challenges and barriers. The first year was a huge success but we were not sure how we were going to incorporate this into 173 other sites. An intensive communication program was implemented to bring the District Leadership into the decision making circle. We first started by meeting with our Superintendent, Chief Academic Officer and our Chief Operating Officer to let them know of our intentions. Once we had their support we reached out to Principals at all levels and through their district leadership groups. Our first group of schools came aboard in 2006. Schools that were 85% or greater Free and Reduced, were identified as the 100% Accessible Breakfast Program schools. The first year we served over 4 million meals or 10% of our enrollment. As each group of schools was added to the program a communication campaign was launched to inform the school administration, parents and the community of the program being offered. Marketing letters, flyers and call-outs were used to inform the stakeholders of the 100% Accessible Breakfast Program. implemented a procedure for the way schools were added each year to be able to impact the most students. In FY 2006-2007 the 100% Accessible Breakfast Program was implemented in schools that were 80% or greater free and reduced. The program was featured in 37 schools and resulted in an increase of over 327,000 breakfast meals. We also believe that our "Power Up With Breakfast" program campaign theme resulted in the ability to increase breakfast participation to 11% of our total enrollment. In FY 2007-2008 the percentage was lowered to 50% or greater free and reduced and the program was introduced to an additional 22 schools which resulted in an increase of 450,000 meals. No new schools qualified in FY 2008-2009 but we served an additional 400,000 meals. In FY 2009-2010 the percentage was maintained at 50%. But due to an increase in the numbers of students qualifying for free and reduced meals status the number of schools qualifying at the 50% level increased to an additional 9 schools. The addition, 9 schools increased the number of breakfasts served to an additional 717,500 meals over the previous year. In FY 2010-2011 the qualifying percentage was lowered to 40%. The qualifying percent for schools to participate was lowered to allow additional sites to take advantage of the program. As our district's free and reduced percentage climbed to 55% our SFS Department believed that it was necessary to find additional ways to support our families. An additional 606,600 meals were served in 2011. The FY 2011-2012 school year opened with an additional 24 sites bringing the total to 143 school sites receiving a free 100% Accessible Breakfast Program resulting in an increase of 426,000 additional meals. Over this 6 year period we increased breakfast participation to 20% of our total enrollment. The participation among students that received the USDA's School Breakfast Program nationally is 19%. We have gone from serving just over 4 million breakfast meals in 2006 to nearly 7 million meals in 2012. In

FY 2012-2013, the SFS Department made a decision to add the last 53 schools that were below the 40% cut off. While it is true that these students are in the highest socio-economic group we were sure that we would see a modest increase in participation. The 53 schools that began receiving free breakfast on October 1, 2012 increased participation in the second week by 150%. The participation of paid students increased by 250%. One thing is sure, whether a child has food available at home or not the 100% Accessible Breakfast Program creates a level playing field for all children with good nutrition. Thank you.

<u>Seth B.</u> Congratulations. The 100% Accessible Breakfast Program over the years has been amazing.

**Lori D.** Millions of dollars of Federal funding is left on the table every year by school districts across the country because they are not maximizing the programs. There are hungry children just wanting to receive those meals. It is in the best interest of every school district to make sure that Federal dollars are used to feed as many children as possible especially at breakfast.

<u>Patrice S.</u> 211 Palm Beach Treasure Coast... One of the formulas to figure the number of homeless children in the District is to look at the free portion of the Free and Reduced meals. Students receiving free lunch last year equated to 70,000 children. The School District of Palm Beach County identified 1,600 children homeless but with that equation we would be looking at 7,000 homeless children in Palm Beach County (PBC). November 10-18, 2012 is National Hunger and Homelessness Awareness Week.

**Lori D.** Over 27 years ago when I first started with the District, free and reduced participation was a low percentage. Every year that number increases because the economy is treacherous. We are now up to almost 57% of free and reduced participation in PBC. My concern is for those gap children who do not qualify for free and reduced and whose families do seem like they are doing just fine – but, they are not. Those are the children that we are happy to reach with this program - with breakfast in their stomach it will allow them to start the day well.

**Paula T.** Thank you Lori.

Next we have Stacey Lazos from HealthTeacher.

**Stacey L.** Thank you for inviting us back. HealthTeacher is a free resource available to teachers. We are sponsored by Miami Children's Hospital and the program is in Palm Beach, Broward and rolling into Dade this school year. Today I brought my boss – Ms. Debra Hopkins, Regional Vice President and she will present all the new additions that HealthTeacher has that we are so proud to offer.

**Debra H.** Good morning...I am absolutely delighted to be here from Nashville, Tennessee. We all share a common spirit to lift up and celebrate health throughout Palm Beach County. How many of you face barriers in the work that you do? We at HealthTeacher have spent the last year trying to remove the barriers. Teachers say they do not have enough time – time is a barrier. Another barrier is the focus on FCAT and now the Common Core Standards. We will show you some of the things to get people excited about integrating health into the day from our HealthTeacher website. We are adding 5 new lessons a month. They align with the Next Generation Sunshine State Standards, Common Core, and Marzano. All lessons take 15 minutes and we want to make it easy for everyone. How many minutes of physical activity do you need every day? This information is smart-board compatible and it is interactive. It is not natural for

kids to sit for hours. We are going to build in physical activity during the day. *Interactive video was shown...* 

The energy level and excitement that this brings into the classroom is easy for teachers to do. There are lots of reasons why people do not exercise. *Video was shown...* 

Real instruction is based around these videos which are used to set the stage. The text is written at grade level appropriate. The kids get to read informational text based on a health topic and then they get to respond with Common Core Standards formatted questions by asking them to give two examples from the text. When we assess we offer a rubric which offers career readiness type skills like decision making and goal setting.

We want to reach out to parents as well so we created a parent website with wonderful newsletters on trending topics about health. We have a new anti-bullying website as well <a href="http://awesomeupstander.com/">http://awesomeupstander.com/</a>

We are so proud to work with The School District of Palm Beach County and thank you for the invitation.

**Paula T.** Thank you Debra – your presentation was *Awesome*.

I would like to introduce Perry Borman, Executive Director of the Palm Beach County Food Bank – formerly the Department of Children and Families' Circuit 15 Administrator.

**Perry B.** I am here to thank Paula, Steve, the Wellness Promotion Task Force, the SFS Department and the entire school administration. We just recently launched the **Soul Source Project** where each school in the District will have the ability to collect non-perishable goods with Principal's approval to support our community of Palm Beach County.

The Palm Beach County Food Bank is a new name. We got incorporated in February of this year and moved into a food bank facility 45 days ago. The Food Bank is absorption of a community food truck organization that has been in existence for the past 9 years called the Community Food Alliance. Our purpose and our mission are to do more for our agencies that take on the responsibility of feeding the hungry every day. Strengthen the wholesale distribution which is the priority and mission for the Palm Beach County Food Bank. The significant need in our hunger supply chain is to strengthen the wholesale distribution system. There are hundreds of organizations in PBC like small church pantries – Boca Helping Hands, Palm Beach Soup Kitchen, El Sol that need help with food.

<u>Paula T.</u> We had the privilege to recently present the <u>Soul Source Project</u> to the Superintendent's A & S meeting on October 9, 2012. We will start this project with our SFS Managers as being the conduits at the school sites. The collecting *green bins* can be placed in the cafeteria area or wherever the School Principal/Administration decides to place them – either the front office or any other logical location. We want to start collecting from the staff and let them be the example leaders. If some schools wanted to promote it through the students we could do that - but at first we will like to start with the school staff. Many others do things already in their schools collecting food - we are trying to connect the dots and help our community even further. The District also has supported the Channel 5 – Food for Families campaign for many years. I know that Perry is working with key individuals at Channel 5 to see how we can further this collaboration and make the **Soul Source Project** sustainable in the District. We will report to you the total collections from this project throughout the school year.

This day is national "Food Day" and the Palm Beach County Food Bank will be hosting an event at Mounts Botanical Garden from 1:30p.m. – 4:00p.m. Steve and Paula are part of a panel discussion along with representatives from the agricultural community, Localecopia, and the Cooperative Extension Service. The panel will be moderated by Jan Norris – former Food Editor from The Palm Beach Post. Food Day is about 5 principles:

- ✓ Promote safer, healthier diets
- ✓ Support sustainable and organic farms
- ✓ Reduce hunger
- ✓ Reform factory farms to protect the environment and animals
- ✓ Support fair working conditions for food and farm workers

<u>Christine K.</u> Congratulations to the WPTF on 7 years, I remember meeting in a small room in Riviera Beach with just a few people. This is a spectacular group and I congratulate you on all you do. I also want to thank the School District on all their support to the United Way. Thank you - Keith Oswald and Seth Bernstein for being Board Members. Steve and Paula - thank you for your participation and support.

Everyone can donate to the United Way and designate your dollars to a specific non-profit or you can contribute to United Way's Community Care Fund. There are 50 programs this year funded with your dollars based on the needs of the community. #### Other School/Departments Based Activities - Updates:

**<u>Keith O.</u>** Division of Curriculum & Learning Support — The School Board has approved a Student Code of Conduct which has not been revised in years. We have 100% of our schools that have implemented school-wide positive behavior support. In every school we have universal expectations around student behavior. We are going out to schools and teaching behaviors in school campuses in a positive way in order to reduce the number students getting suspensions and referrals. We are working to strengthen School Based Teams (SBT) by working with partners like United Way and numerous agencies like 211 in our community to provide social-emotional support.

**Eric S.** Division of Curriculum & Learning Support –

- Miami Children's Hospital chose The School District of Palm Beach County for HealthTeacher before Dade and Broward schools because of the work of the special people in this room.
- Perry we have collected over 3,000 pounds of food from our PE team for the past 4 years. A healthy food choice is an admission ticket to our Professional Development Trainings.
- Mindy Haas is here and has a 6 year commitment to Florida PTA Board and health and wellness is her platform throughout the state.
- The year 2 PEP grant for PE programs was re-funded. We received the award letter on October 1, 2012. We will work with an additional 36 elementary schools in addition to the 36 from last school year. This will include Royal Palm School and Palm Beach School for Autism.
- We are honored that Patricia Martin from John I. Leonard High is in the audience today. She was named the Florida High School Physical Education Teacher of the Year.
- Our schools have just completed a Fuel Up to Play 60 grant cycle in which we have received over \$50,000 in grant money so far. This is a partnership with the NFL and the National Dairy Council.
- We have the 2<sup>nd</sup> South Florida Fair Kids Mile on January 19, 2013 and we need volunteers. Last year there were 1,800 kids in the race.
- I am on the Executive Committee for the Florida Action for Healthy Kids and the Coordinated School Health Partnership with the Department of Health and the Department of Education in Tallahassee.
- In 2009, a small committee of us from this room completed a Florida Healthy School District Self Assessment Tool that the state put out. The School District was awarded Silver Level recognition for 2009–2011. This year we were awarded Gold Level recognition for 2012-2014. There were only 3 school districts in Florida that received the Gold Level Status. We are so far ahead when it comes to Wellness.

- North Grade Elementary. We had a planting on October 10, 2012 at North Grade Elementary. Deputies from the PBC Sheriff's Office put in the irrigation system with the support of our Facilities Department. We installed a wheelchair accessible sidewalk. It has been an amazing partnership. I was reminded of this by a presentation that I did at Bridges in West Palm Beach. Students from ages 8-16 were open about their experiences with nutrition – their fights over food and snacks.
