SUBJECT: STUDENT REASSIGNMENT, 2013-14

The application window for student reassignment requests for 2013-14 will open on Monday, April 1, 2013 and will remain open through June 1, 2013. Approved reassignments will take effect on Monday, August 19, 2013, the first day of the 2013-14 school year. Approval of a reassignment request will serve as the student's school choice option for 2013-14.

The list of schools open for reassignment was reviewed and approved by Area Superintendents. As a courtesy, the Department of Choice and Career Options will notify principals of all approved reassignments. A list that includes student initials, student numbers, reason for reassignment, and school from which the student is being reassigned will be sent to applicable principals beginning July, 2013. After initial notification email, principals will be informed of any additional reassignments to their school.
