Old Business	Mental Health Subcommittee – Sharon Tarlow gave a report for Dr. Bernstein.  The committee had a special meeting January 3 <sup>rd</sup> to review the CDC's Youth Risk Behavior Survey (YRBS) for 2013 and provide recommendations for additional questions, as well as finalize a white paper for the school district explaining the purpose, importance and use of the survey. Many thanks to everyone involved in the meeting for their input into the draft white paper presented by Dr. Fishbane and for their review and recommendations of questions to be added to the local YRBS.  The white paper including the recommended new additional YRBS questions had been emailed to SHAC members prior to the meeting. Dr. Fishbane gave a brief overview of the white paper and the process for determining the additional recommended questions. She acknowledged Dani Fitzgerald and Pete Steward for tremendous behind-the-scenes work organizing the review for the committee of the 142 possible questions from the CDC. All questions considered had been previously validated and sanctioned by the CDC. The committee deliberations were very thorough; questions selected addressed wide range of youth concerns. SHAC members felt the paper and its recommendations were fine; only questions were relative to the actual survey process. The 2013 YRBS survey will be given to randomly selected classes in all PBC high schools (9 <sup>th</sup> – 12 <sup>th</sup> grades) this spring. CDC has been conducting these surveys since the early 1990s and PBC has participated since 1999 in the biennual YRBS.
