Any bidder adversely affected by the decision or intended decision of the School Board must file a notice of protest, in writing, within 72 hours after the posting, and file a formal written protest (petition) within 10 days after the date the notice of protest is filed as required by Section 120.57, Fla. Stat. and SB Policy 6.14. The formal written protest shall state with particularity the facts and law upon which the protest is based and shall contain all the information specified in either Rule 28-106.201(2), F.A.C., or Rule 28-106.301(2), whichever applies. Failure to file a notice of protest or failure to file a formal written protest within the time prescribed in Section 120.57(3), Fla. Stat., will constitute a waiver of proceedings under Chapter 120, Fla. Stat. Any person who files an action protesting a decision or intended decision pertaining to this bid pursuant to Section 120.57(3) (b), Fla. Stat. shall post with the Purchasing Department, at the time of filing the formal written protest, a bond secured by an acceptable surety company in Florida payable to the School District of Palm Beach County in the amount of five thousand dollars (\$5,000) or 1 percent of the lowest accepted bid, whichever is greater, for projects valued over \$500,000.00, or 5 percent of the lowest accepted bid for all other projects, as stated in Section 255.0516, Fla. Stat. Failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Fla. Stat.
