## **EXECUTIVE SUMMARY**

August 30, 2017

SUBJECT: REVISED FY17 RESULTS OF THE TEACHER/STAFF SCHOOL EFFECTIVENESS QUESTIONNAIRE

On May 4, 2017 the District released the results of the FY17 Teacher/Staff School Effectiveness Questionnaire (SEQ). Unfortunately, during a subsequent review of the analysis an error was found in the coding used to produce the report. The following is the revised report detailing the results from the corrected analysis.

The School Effectiveness Questionnaire (SEQ) was administered from January to February 2017. The SEQ measures perceptions regarding the effectiveness of our District schools.<sup>1</sup> For FY17, the District administered the Teacher/Staff version online for the seventh year.<sup>2</sup> The SEQ provides important information to schools and the District to develop and sustain a Positive and Supportive School Climate, which is a central theme in the Strategic Plan. The categories for the SEQ were developed from the results of a factor analysis and a review of national school climate surveys.<sup>3</sup> The categories in the SEQ are: Instructional Leadership, High Expectations, School Climate, Decision Making, and Student Conduct. A review of the FY17 Teacher/Staff SEQ results reveal the following:

# **Response Rates**

- The FY17 response rate for the District increased from 54% to 68%.
- While the overall response rate increased, the number of respondents leaving individual item blank increased significantly from FY16 to FY17.
- From FY16 to FY17, response rates at:
  - o Elementary schools increased from 57% to 74%;
  - Middle schools increased from 49% to 59%;
  - High schools increased from 51% to 63%.

<sup>&</sup>lt;sup>1</sup> In FY2011, a sixteen-member committee of school and central-office administrators revised the SEQ after a review of national school climate surveys and the District's need for more information related to issues affecting our schools.

<sup>&</sup>lt;sup>2</sup> The District used a third-party purveyor to administer the teacher/staff version in order to reduce costs and ensure anonymity of respondents.

<sup>&</sup>lt;sup>3</sup> Survey items that are highly inter-correlated or loaded more closely together are supposed to measure the same construct or conceptual category. The average of these item responses composed a category score. This allows the categories to have statistical support. Category labels were taken from research literature related to the structure of school climate.

#### **Percent Positive Responses**

The percent positive responses are comprised of those responses on the SEQ Likert scales that denote agreement (strongly, moderately, or slightly agree), the extent of influence for decision making (moderate influence or a great deal of influence), or the degree of concern for student conduct (where adverse conduct is a minor problem or not a problem). As a result in the increase in individual items left blank, the FY17 percent positive response analysis for each item (and category) excludes non-responses from the percentages. This method provides a more accurate measure of staff responses to each item. The FY15 and FY16 data have been recomputed to allow for comparison between years.

From FY16 to FY17, the percent of positive responses:

- Remained stable overall
- Improved somewhat in the categories of Instructional Leadership, High Expectations, and School Climate
- Decreased in teacher involvement in Decision Making and Student Conduct.

#### **School Level Percent Positive Responses**

From FY16 to FY17, the school level percent positive responses:

- Remained stable in Elementary for Instructional Leadership, High Expectations, and School Climate and declined in in teacher involvement in Decision Making and Student Conduct.
- Improved in Middle School for Instructional Leadership, High Expectations, and School Climate and declined in teacher involvement in Decision Making and Student Conduct.
- Improved in High School for Instructional Leadership, High Expectations, and School Climate; remained stable in teacher involvement in Decision Making and declined in Student Conduct.
