The Committee shall consist of seven (7) citizens of Palm Beach County, Florida who are volunteers, are not District employees and who exhibit a broad range of interests, including knowledge and interests in budget matters. Each School Board member shall appoint a member to the Committee. The terms of the committee members shall be-as provided in Board Policy 1.09 (Advisory Committees to the Board).
