**POLICY 2.18**

**TITLE**

3 ~~1. All employees who drive District buses must comply with standards established by~~  
4 ~~the Superintendent.~~
- 5 ~~2. Any employee who knowingly operates a District bus with a suspended or revoked~~  
6 ~~license may be subject to disciplinary action up to and including termination.~~
- 7 ~~3. Applicants for the position of school bus driver will not be hired if their driver history~~  
8 ~~record contains either a plea of guilty or nolo contendere or an adjudication within~~  
9 ~~the preceding seven (7) years for one of the following crimes:~~
- 10 ~~a. Driving under the influence of alcoholic beverages, chemical substances or~~  
11 ~~controlled substances, or with unlawful blood alcohol levels;~~
- 12 ~~b. Leaving the scene of an accident where there was an injury and/or property~~  
13 ~~damage exceeding \$500.00;~~
- 14 ~~c. Reckless driving resulting in an accident;~~
- 15 ~~d. Fleeing or attempting to elude a police officer.~~
- 16 ~~4. Employees who operate a District bus during the performance of their regular~~  
17 ~~duties and who plead nolo contendere or guilty, or who are found guilty committing~~  
18 ~~any of the crimes listed in Section 4 of this policy, will be subject to disciplinary~~  
19 ~~action up to and including termination.~~
