## **CONSENT ITEM**

• The Board adopted Policy 6.143 on May 11, 2005. Section (15) provides:

Implementation by the Superintendent.-- Wherever this Policy mentions procedures to be established or implemented by the Superintendent, certain internal operational procedures and guidelines may be set forth in Bulletins where appropriate. Other more *formal procedures, when sufficiently developed and solidified, should be recommended to the Board, where appropriate, for adoption as Policy.* 

- An M/WBE and SBE procedures manual has been drafted by an outside consulting firm (based in part upon Policy 6.146B, which was the prior M/WBE procedural policy before it sunset in 2001); it was then reviewed by District staff; it was next reviewed and revised by the Legal Department; and it was then reviewed by expert outside counsel.
- The procedures manual is being incorporated by reference in this Policy.
- The Board approved development of this amendment at the special meeting on Policies on March 29, 2006.
