CONSENT ITEM

- Provisions relating to the disposal of instructional materials are deleted from this Policy as they appear in Policy 8.122(5).

- 7 2. The Superintendent shall dispose of tangible property (equipment, furniture, buses,
8 vehicles, etc.) in accordance with Section ~~235.042(2), 1013.28(2), FS , but ,3.~~
9 ~~—The Superintendent he/she shall dispose of obsolete or surplus instructional~~
10 ~~materials in accordance with State Board of Education rule 6A-7.74, FAC, as~~
11 ~~provided within Section 1006.41, FS. and School Board Policy 8.122(5). and in the~~

- 13 a. ~~Given to other public education programs within the district or state.~~
- 14 b. ~~Given to the teachers to use in developing supplementary teaching materials.~~

- 27 3. Pursuant to Section 1002.33 (18)(e), FS, if "a district school board facility or
28 property is available because it is surplus, marked for disposal, or otherwise
29 unused, it shall be provided for a charter school's use on the same basis as it is
30 made available to other public schools in the district." No public school within the
31 district shall have access to another public school's facility for use, except through
32 School Board Policy 7.012 relating to Interim Property.
