5-A I recommend that the Board approve development of the proposed revised Policy 8.01, entitled "Promotion, Placement and Graduation – Student Progression Plans."

Development

CONSENT ITEM

- Pursuant to Section 1008.25, Florida Statutes: Public school student progression, remedial instruction, promotion, and reporting requirements require that each district school board shall establish a comprehensive program for student progression. The 2008-2009 Student Progression Plans (Elementary School, Middle School, High School, and Adult), which are attached to the proposed emergency rule that appears as item 4-K on the August 27, 2008 agenda, contain the revisions to the Plans to reflect the requirements of Florida Statutes and State Board of Education Rules.
- This revision will incorporate the 2008-2009 editions of the Student Progression Plans into Policy 8.01 immediately upon adoption.
- A recommendation for adoption of an emergency rule (8.01-ER) is also being made on August 20, 2008 because it is important that the amendments to the Plans be incorporated as close as possible to the beginning of the school year. The regular revision process is likely to be completed before the emergency rule expires on November 25, 2008.
- Revisions include:
 - Modified wording for Exceptional Student Education, Students with Disabilities and Students with an Active 504 Accommodation Plan to reflect statutes, rules and policies
 - Added language to clarify Physical Education requirements (elementary and high school) and waiver options (high school)
 - Eliminated second semester exam exemptions for underclassmen
 - o Revised Special Diploma Option 2; eliminated Option 1

- Eliminated Three-year 18-credit College and Career Preparatory Programs for students declaring in 2004-05
- Revised charts and language to reflect remediation requirements and progress monitoring plans
- Revised language and arrangement of sections to align the Plans

- 1. The School Board of Palm Beach County values the educational development of each student in the District. District instructional personnel will consider the individual student's academic needs when placing students in subjects, grade levels or specialty programs.
- 8 Promotion between grade levels shall be based upon evaluation of each student's 2. 9 performance and achievement. To assist and guide school officials in their 10 decisions on placement, promotion, retention, and special programs, the Superintendent has developed the 2007-2008 2008-2009 Student Progression 11 12 Plans (as revised by the Board on January 30, 2008), which are incorporated by reference into this Board Policy. Copies of the Plans shall be maintained in the 13 14 and District office at each school and are available online at www.palmbeach.k12.fl.us/curriculumlearningsupport 15 and 16 www.palmbeach.k12.fl.us/documents/#SPP. The Plans must include student performance standards and promotional and graduation requirements for grades K-17 18 12, adult general education, exceptional student education, and dual enrollment. 19 Before being presented to the Board for annual approval, the revised and updated Student Progression Plan will be reviewed for compliance with federal law and 20 Florida law and State Board of Education rules, and the Plans shall be interpreted 21 and implemented consistent with federal and state law. 22

- As required by Fla. Stat. § 1008.25(7)(b)5, the District shall annually publish in the
 local newspaper any revisions to this Policy on student retention and promotion
 from the prior year, referring to changes in the Student Progression Plan
 incorporated into this Policy.
