- The Board approved this revision as a first reading for development on June 2, 2003. The adoption notice was published on June 30, 2003.
- The Board adopted revisions to the Code of Conduct Policies, 5.1812 and 5.1813, on January 13, 2003. The executive summary for the revision of Policies 5.1812 and 5.1813 stated: "Once these policies are approved, then Policy 5.1811 Student Code of Conduct Terms, will need to be updated to reflect the minor definitional changes and provide consistency between the policies."
- This revision updates statutory citations and brings the definitions into conformity with Policies 5.1812 and 5.1813, which the Board revised on Jan. 13, 2003.

POLICY 5.1811

STUDENT CODE OF CONDUCT TERMS⁴

- 1. As used in the Policies comprising the student code of conduct (such as Policies 5.18, 5.1812, 5.1813, 5.1814, 5.186, and 5.80), the terms listed below in the "Term" column shall be defined as set forth in the "Meaning" column unless specifically defined differently in a particular Policy or portion thereof.
- <u>2. As stated in Policies 5.1812 and 5.1813</u>, ⁴The School Board of Palm Beach County recognizes that the code of student conduct must be construed to be consistent with the Individuals with Disabilities Education Act ("IDEA") and Section 504 of the Rehabilitation Act ("Section 504"). Therefore, students eligible for services under the IDEA or Section 504, will be disciplined in accordance with these Acts and are governed by those School Board Policies which specify that they apply to students covered under IDEA and 504.

The threat is more direct and more concrete than a low level threat; the wording in the threat suggests that the threatener has given some thought to how the act will be carried out; there may be a general indication of a possible place and time (though these signs still fall well short of a detailed plan); There is no strong indication that the threatener has taken preparatory steps, although there may be some veiled reference or ambiguous or inconclusive evidence pointing to the possibility-an illusion allusion to a book or movie that shows the planning of a violent act, or a vague, general statement about the availability of weapons; there may be a specific statement seeking to convey that the threat is not employ. Example: "I'm serious!" or "really mean this!" (3) High level of threat is a threat that appears to pose an imminent and serious danger to the safety of others; the threat is direct, specific, and plausible; the threat suggests concrete steps have been taken toward carrying it out, for example, statements indicating that the threatener has acquired or practiced with a weapon or has had the victim under surveillance. | Threat (Categories in incident codes 28, 46, and 89) | Regarding incident codes 28, 46, and 89, the categories of threat are: (1) Direct threat identifies a specific act against a specific target and is delivered in a straightforward, clear, and explicit manner. Example: "I am going to place a bomb in the school's gym." (2) Indirect threat tends to be vague, unclear and ambiguous. The plan, the intended victim, the motivation, and other aspects of the threat are masked or equivocal. Example: "If I wanted to, I could kill everyone at this school!" | | implied, the threat is phrased tentatively-"If I wanted"-and suggests that a violent act could occur, not that it will occur. (3) Veiled threat is one that strongly implies but does not explicitly threaten violence. (4) Conditional threat is the type of threat often seen in extortion cases. It warns that a violent act will happen unless certain demands or terms are met. Example: "If you don't | | |
