Adoption CONSENT ITEM

- The Board approved this revision as a first reading for development on July 28, 2003. The adoption notice was published on August 11, 2003.
- The minor revisions proposed in this Policy and three others in Chapter 7 are needed to implement amendments to the Interlocal Agreement for Concurrency, on which at least 51% of the municipalities have recently signed off.
- Nomenclature, terminology, and statutory citations are also updated to reflect the new K-20 Education Code. For example, the Five-Year Capital Facilities Plan is renamed to conform to Fla. Stat. § 1013.35 and SREF as the "Five-Year District Facilities Work Program."
- Fla. Stat. § 1013.35(2)(b) makes the adopted Five-Year Facilities Work Program a part of the tentative District Educational Facilities Plan (including tentative 10- and 20-year plans), which also contains the educational plant survey pursuant to Fla. Stat. § 1013.35(1)(a), (2).
