CONTRACT RENEWAL

Request for Proposal No. 03C-008B was awarded by Board action on April 23, 2003, to Coach Comp America and JFK Medical Center for two years from April 24, 2003 through April 23, 2005 with the option to renew for two additional one-year periods.

By Board action on March 16, 2005, the first option to renew was exercised for the period April 24, 2005 through April 23, 2006

The second and final option to renew is now being exercised for the period April 24, 2006 through April 23, 2007.

Coach Comp America and JFK Medical Center have agreed to honor terms, conditions and pricing of existing contract for the forthcoming contract period.

Services to be provided include drug screenings for new employees and substitute teachers, pre-placement and annual physicals for drivers who are required to operate District vehicles with a Commercial Driver's License, pre-placement physicals for School Police, drug screenings, Tuberculin test, environmental pre-placement and annual physical examinations, fitness for duty evaluations, Hepatitis B vaccinations and post exposure follow-up. Award is made by geographical area. Prices are firm.

RECOMMENDATION: Based on satisfactory performance during the past contract period, it is recommended that the RFP for Applicant and Employee Health Screening Services be renewed with Coach Comp America and JFK Medical Center for the period April 24, 2006 through April 23, 2007.

Purchase orders processed from April 22, 1999 through March 7, 2003 total \$875,567.

Services to be provided include, drug screenings and Tuberculin test for new employees and substitute teachers, pre-placement and annual physicals for drivers who are required to operate District vehicles with a Commercial Driver’s License, pre-placement physicals for School Police, drug screenings, Tuberculin test, environmental pre-placement and annual physical examinations, fitness for duty evaluations, Hepatitis B vaccinations and post exposure follow-up. Drug screenings and Tuberculin test were not previously provided for substitute teachers. They have been added to this contract. Award is made by geographical area. Prices bid are firm.


CONSIDERATION OF INDEMNIFICATION: Awardee(s) recognizes that in order to comply with FS 725.06 the District must include an amount paid to the awardee(s) in consideration for the awardee(s) agreeing to indemnify the District. The amount of TEN DOLLARS (\$10) to be included on the awardee(s) initial invoice, per Special Condition, Indemnification and Hold Harmless, as consideration for this contract.

The Evaluation Committee, consisting of District staff, convened and reviewed all responsive proposals. It is the recommendation of the Committee to award this contract to the highest rated proposer for each geographical area.

RECOMMENDATION: I recommend contract award be made to the highest rated responsive, responsible proposer in each geographical area based on the evaluation criteria outlined in the RFP.

Failure to file a protest within the time prescribed in §120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes and applicable Board rules, regulations and policies. Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

If a proposer wishes to protest a RFP, they must do so in strict accordance with the procedures outlined in FS 120.57(3). Any person who files an action protesting a decision or intended decision pertaining to this RFP pursuant to FS 120.57(3)(b), shall post with the Purchasing Department, at the time of filing the formal written protest, a bond secured by an acceptable surety company in Florida payable to the School District of Palm Beach County in an amount equal to 1 percent (1%) of the total estimated contract value, but not less than \$500 nor more than \$5,000. Bond shall be conditioned upon the payment of all costs that may be adjudged against the protester in the administrative hearing in which the action is brought and in any subsequent appellate court proceeding. In lieu of a bond, a cashier’s check, certified bank check, bank certified company check or money order will be acceptable form of security. If, after completion of the administrative hearing process and any appellate court proceedings, the District prevails, it shall recover all costs and charges included in the final order of judgment, including charges by the Division of Administrative Hearings. Upon payment of such costs and charges by the protester, the protest security shall be returned. If the protest prevails, he or she shall recover from the District all costs and charges, which shall be included in the final order of judgment.
