- 1. The School Board of Palm Beach County values the educational development of each student in the district. District instructional personnel will consider the individual student's academic needs when placing students in subjects, grade levels, or specialty programs.
- 2. Promotion between grade levels shall be based upon evaluation of each student's performance and achievement. To assist and guide school officials in their decisions on placement, promotion, retention, and special programs, the Superintendent has developed <a href="mailto:the-2005-2006">the 2005-2006</a> a Student Progression Plang 2003-2004, which <a href="mailto:are-is-incorporated">are-is-incorporated</a> by reference into this Board policy. Copies of the Plang shall be maintained in the District office and at each school <a href="mailto:and-are-available-online-at-http://www.palmbeach.k12.fl.us/documents/#SPP">http://www.palmbeach.k12.fl.us/documents/#SPP</a>. The Plang must include student performance standards and promotional and graduation requirements for grades K-12, adult general education, exceptional student education, and dual enrollment. Before being presented to the Board for annual approval, the revised and updated Student Progression Plan will be reviewed for compliance with Florida law and State Board of Education rules.
- 3. As required by Fla. Stat. § 1008.25(7)(b)5, the District shall annually publish in the local newspaper any revisions to this policy on student retention and promotion from the prior year, referring to changes in the Student Progression Plan incorporated into this Policy.
