## **Presentation of Subject Matter**

### Within the specified time frame of this component, participants will:

- 1. demonstrate an understanding of efficient use of time, subject matter, lesson development, teacher treatment of student response, feedback, and management of seat work and homework. (2 points)
- 2. identify presentation of conceptual, explanatory, academic rule, and of value knowledge. (2 points)
- 3. specify how students can be oriented to class work and the purpose of activities. (2 points)
- 4. identify how both factual and analytical type questions are effective teaching strategies. (2 points)
- 5. demonstrate the understanding of how to give clear directions for individual and cooperative class work as well as homework. (2 points)
- 6. identify well defined learner objectives, and relate these objectives to the instructional activity. (2 points)
- 7. demonstrate an understanding of how to plan and implement lessons connecting goals, learning activities, outcomes, and evaluation. (3 points)

### **Management of Student Conduct**

### Within the specified time frame of this component, participants will:

- 8. demonstrate the knowledge of appropriate management of student conduct techniques. (4 points)
- 9. specify how verbal and nonverbal communication affects student behavior. (4 points)
- 10. identify appropriate student behaviors. (3 points)
- 11. identify effective classroom rules and procedures. (4 points)

#### **Communication**

# Within the specified time frame of this component, participants will:

- 12. demonstrate an understanding of how verbal and nonverbal communication affects student behavior. (3 points)
- 13. identify effective ways to provide constructive feedback. (3 points)
- 14. identify the knowledge of physical, social, and emotional characteristics of students. (3 points)
- 15. demonstrate effective communication skills with parents/guardians and co-workers. (3 points)
- 16. ensure an understanding of culturally diverse populations. (3 points)

### **Learning Environment**

## Within the specified time frame of this component, participants will:

- 17. demonstrate how to create a safe, orderly learning environment. (3 points)
- 18. design efficient and effective routines. (3 points)
- 19. demonstrate an understanding of how to create learning environments in which all students are treated equitably. (3 points)
- 20. demonstrate an understanding of how effective classroom procedures enhance the learning environment. (3 points)
- 21. identify a climate of openness, mutual respect, support, and inquiry. (3points)

#### **PROCEDURES:**

The participants will:

- 1. participate in on-site professional development.
- 2. participate in both small and whole group discussions.
- 3. model techniques and strategies.
- 4. role play.
- 5. read and analyze journal articles (current research).
- 6. create materials and products to use in their classrooms.

#### **EVALUATION OF PARTICIPANTS:**

#### **FOLLOW-UP ACTIVITIES:**

Participants will apply their learning by one or more of the following:
