ADDENDUM NO. 2 TO

CONTRACT NO. 03C-005F BETWEEN

THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA

AND

ROYAL CONCRETE, INC.

This addendum to Contract No. 03C-005F entered into this 3rd day of May 2006, between THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA, a political subdivision of the state of Florida, (hereinafter referred to as the "School Board") and Royal Concrete Concepts, Inc. a Florida corporation, located at 801 Pike Road, West Palm Beach, Florida 33411, (hereinafter referred to as the "Contractor").

The School Board and Contractor hereby agree to the following amendments to Contract No. 03C-005F dated April 15, 2003:

- 1. The term of the Contract shall be renewed through May 12, 2007.
- 2. The terms of the Contract No. 03C-005F ("Contract") shall be amended to include the following additions and changes to the standard modular classroom and non-instructional buildings:
 - a. The bathrooms shall now contain ceramic tile flooring as standard. The bathrooms will no longer contain roll vinyl flooring;
 - b. The Vinyl Composition Tile has been upgraded to an Armstrong Product;
 - c. The roofing shall be a 2-ply peel and stick membrane system;
 - d. The modulars shall include all conduits and electric for the LCD projection system;
 - e. The modulars shall include roughs for future plumbing; and
 - f. There shall be an addition of either the Teacher workstation or the counter and sink area as standard. School Board to advise which item it desires to have.

To the extent that the above terms conflict with current terms of the Contract, the above terms shall amend supersede all conflicting terms.

- 3. The attached Cost of Services dated April 14, 2006, shall amend and supersede the previously submitted Cost of Services. A copy of the Cost or Services dated April 14, 2006 is attached and incorporated as **Exhibit 1**.
- 4. All other terms and conditions of the Contract remain the same.
