Development

CONSENT ITEM

- Revisions are recommended at lines 11-12, 166-171, and 177-184 to conform with amendments to the relevant statutes, pursuant to Ch. 2006-74, Laws of Florida (which took effect on June 5, 2006), and to require that school improvement plans must address single school culture.
- Additional minor revisions are recommended for reasons of practicality.
- To make the Policy more compact, the text of the sample SAC bylaws is being deleted. The sample bylaws will be available on the Web site of the Department of School Improvement.

SCHOOL ADVISORY COUNCILS

5 1. School Advisory Council.-- Each school in this school district shall have a School
6 Advisory Council ("SAC") as set forth in Fla. Stat. § 1001.452(1)(a).

7
8 2. Composition of Councils

9
10 a. Fla. Stat. § 1001.452(1)(a) requires that school advisory council membership
11 include the school principal/director (who, pursuant to Fla. Stat. § 1001.54(2),
12 must provide instructional leadership in the development, revision, and
13 implementation of the school improvement plan) and an appropriately balanced
14 number of teachers, education support employees, students (where appropriate),
15 parents, and business and community representatives.

16 i. Middle and junior high schools must include student representation on their SACs.

17 ii. Vocational-Technical centers and high schools must include student representatives on their SACs.

18 iii. Vocational-Technical centers and adult education centers are not required to have parent participation on the SACs.

19 iv. In accordance with Fla. Stat. § 1001.452(1)(a), the term "education support employee" as used here refers to any
20 person who is employed by a school who is not defined as instructional or administrative personnel pursuant to Fla.
21 Stat. § 1012.01 and whose duties require twenty (20) or more hours in each normal working week.

22 v. For purposes of school advisory council membership, the term "teacher" includes classroom teachers, certified
23 student services personnel, and media specialists pursuant to Fla. Stat. § 1001.452(1)(a).

24 b. As required by Fla. Stat. § 1001.452(1)(a), the majority (fifty percent plus one (50% + 1)) of the members of the SAC shall
25 be persons who are not employed by the school.

26 c. Membership shall be representative of the ethnic, racial, and economic community served by the school, as required by
27 Fla. Stat. § 1001.452(1)(a).

33 3. Selection of Council Members

34 a. All council members shall be elected by their respective peer group, except for business and community representatives
35 and the school principal/director. The SAC bylaws will establish the term of membership and a process for ensuring
36 staggered terms to provide continuity on the SAC.

37 b. As required by Fla. Stat. § 1001.452(1)(a), the following council members shall be elected by their respective peer group
38 in a fair and equitable manner through an election as set forth in the bylaws of the SAC. Procedures in the bylaws should
39 include the means of ensuring wide notice of vacancies and elections through such means as the school marquee, school
40 newsletter, Parent Teacher Association/Parent Teacher Organization (PTA/PTO) meetings, and announcements at open
41 house, etc.

42 i. Teacher(s) shall be elected by teachers;

43 ii. Education support employee(s) shall be elected by education support employees;

44 iii. Student(s), when appropriate, shall be elected by students; and

54 iv. Parent(s) members shall be elected by parents in general, with all parents having an opportunity to participate in
55 voting for any parent as set forth in the bylaws of the SAC.
56

57 c. Any SAC member may recommend the appointment of business and community member(s) to serve on the SAC. The
58 procedures in the SAC bylaws will include the means of ensuring wide notice of vacancies through methods such as
59 school marquee, school newsletter, and instructional television, and of taking input on possible members from local
60 business, chambers of commerce, community and civic organizations and groups, and the public at large. Business and
61 community members will be appointed by the principal following the advice and consent of the SAC.
62

63 d. The bylaws of the SAC must set forth a process for appointment of additional SAC members if the election process does
64 not produce representative membership as specified above. If the process set forth in the SAC bylaws still does not
65 produce representative membership, the Board will appoint additional SAC members.
66

67 4. SAC Governance
68

69 a. Each SAC shall be governed by the Sunshine Law, Fla. Stat. § 286.011, Fla. Stat. Chapter 119, Fla. Stat. § 1001.452,
70 and other relevant Florida statutes and State Board of Education Rules relating to SACs.
71

72 b. Each SAC will adopt bylaws, including membership selection procedures, that meet the requirements of Florida Statutes,
73 State Board of Education Rule, and this Board Policy. As required by Fla. Stat. § 1001.452(1)(d), the bylaws must
74 establish procedures for the following:
75

76 i. Requiring a quorum to be present before a vote may be taken by the school advisory council. A majority of the
77 membership of the council constitutes a quorum.
78

79 ii. Requiring at least three (3) business days' advance notice in writing to all members of the advisory council of any
80 matter that is scheduled to come before the council for a vote. (This notice to members is in addition to the meeting
81 notice for the general public under the Sunshine Law).
82

83 iii. Scheduling meetings when parents, students, teachers, businesspersons, and members of the community can
84 attend.
85

86 iv. Replacing any member who has two consecutive unexcused absences (as determined by the SAC Chair) from SAC
87 meetings scheduled according to the procedures in the bylaws.
88

89 v. Recording minutes of meetings (and, as required by Fla. Stat. § 1001.452(1)(d)5, the School Board shall maintain a
90 record of minutes of council meetings).
91

92 c. The SAC shall annually review its bylaws to ensure alignment with current - statutes and Board Policy.
93

94 d. The SAC shall submit the SAC bylaws when submitting the school improvement plan for Board approval.
95

96 5. Validation of SAC Membership Composition
97

98 a. The Superintendent/designee will validate each school's membership composition, including reviewing whether "schools
99 have maximized their efforts to include minority persons and persons of lower socioeconomic status," pursuant to Fla.
100 Stat. § 1001.452(1)(a).
101

102 b. The Superintendent shall annually submit the membership lists of all SACs to the School Board for review during a regular
103 or special Board meeting in, or before, December of each school year.
104

105 i. The School Board shall review the SAC membership composition to determine if it is representative of the ethnic,
106 racial, and economic community served by the school, as required by Fla. Stat. § 1001.452(1)(a).
107

- 108 ii. If necessary to achieve proper representation, the School Board, based on the recommendation of the Board
109 member in whose district the school is located, shall vote to appoint additional members to a SAC.
110

111 6. SAC Powers and Duties
112

- 113 a. Each SAC has the authority to exercise the functions and duties provided to SACs by the Florida Statutes and State
114 Board of Education rules, but has no powers or duties now reserved by law to the Board. Pursuant to Fla. Stat. §
115 1001.452(1)(a), the SAC shall be the sole body responsible for final decision-making at the school relating to
116 implementation of §§ 1001.42(16) and 1008.345, regarding school improvement and accountability.
117
- 118 b. Each SAC shall assist in the preparation and evaluation of the school improvement plan required by Fla. Stat. §
119 1001.42(16). Technical assistance from the DOE may be requested as needed.
120
- 121 c. Each SAC shall assist in the preparation of the school's annual budget and plan as required by § 1001.452(2) and
122 1008.385(1).
123
- 124 d. As required by Fla. Stat. § 1008.36(4), school recognition funds "must be used for purposes listed in [§ 1008.36](5) as
125 determined jointly by the school's staff and school advisory council." For purposes of this subsection, "school staff" means
126 all employees assigned to that school at the time of the decision, including instructional, paraprofessional, clerical,
127 facilities, and food service personnel, consistent with Fla. Stat. § 1012.01(2), (3), (6), (7).
128
- 129 i. Pursuant to Fla. Stat. § 1008.36(5), school recognition funds can be used for any of the following:
130
- 131 A. Nonrecurring bonuses to the faculty and staff;
 - 132
 - 133 B. Nonrecurring expenditures for educational equipment or materials to assist in maintaining and improving
134 student performance; or
 - 135
 - 136 C. Temporary personnel for the school to assist in maintaining and improving student performance.
137
- 138 ii. The following suggested steps could be used for joint determination of the use of school recognition funds: A) the
139 SAC creates proposals for expenditure of the funds; B) the written proposals plus a choice of "None of the Above"
140 are presented to the staff three business days prior to the vote; C) school staff vote by secret ballot on the proposals;
141 and D) the proposal with the majority of votes is implemented (but if no proposal, or "None of the Above," receives at
142 least 50%+1 of the votes, the SAC reconvenes and creates different proposals to be presented to staff). This
143 paragraph is illustrative only; different procedures may be used for joint determination of the use of funds.
144
- 145 iii. Pursuant to Fla. Stat. § 1008.36(4), "If school staff and the school advisory council cannot reach agreement by
146 November 1, the awards must be equally distributed to all classroom teachers currently teaching in the school." The
147 term "classroom teachers" is defined in Fla. Stat. § 1012.01(2)(a) as "staff members assigned the professional
148 activity of instructing students in courses in classroom situations, including basic instruction, exceptional student
149 education, career and technical education, and adult education, including substitute teachers" who are assigned to
150 that school as of the November 1 deadline. (The term does not include other instructional personnel which are
151 separately defined in § 1012.01(2)(b)-(e)).
152
- 153 e. Each SAC shall have access to the District's web site as a means of providing information to the public and other SACs.
154

155 7. School Improvement Plan
156

- 157 a. Each SAC shall assist in the preparation and evaluation of the school
158 improvement plan pursuant to Fla. Stat. §§ 1001.42(16) and 1001.452(2). Each
159 school must have an approved school improvement plan, pursuant to §
160 1001.42(16), after one (1) full school year of planning and development, as

161 required by § 1008.345(6)(c). Accordingly, new schools must have a school
162 improvement plan upon completing one full school year of operation.

163
164 b. ~~As required by Fla. Stat. § 1001.42(16)(a), the~~ The school improvement plan
165 shall address ~~be designed to achieve the state education priorities in Fla. Stat. §~~
166 ~~1000.03(5) and student performance standards, and must include a goal~~
167 ~~concerning student health and fitness, including physical fitness, parental~~
168 ~~information on student health and fitness, and indoor environmental air quality.~~
169 ~~The plan must also address budget, training, instructional materials, technology,~~
170 ~~staffing, student support services, specific school safety and discipline strategies,~~
171 ~~and other matters of resource allocation as determined by Board Policy, single~~
172 ~~school culture and shall include any all matters required by federal law, Fla. Stat.~~
173 ~~§ 1001.42(16)(a) and other Florida Statutes, or the Florida Department of~~
174 ~~Education. The student performance standards to be addressed include both~~
175 ~~Florida state standards and the federal No Child Left Behind Act.~~

176
177 c. ~~Pursuant to Fla. Stat. §§ 1003.415 and 1001.42(16)(a), beginning with the 2004-~~
178 ~~2005 school year each public school serving middle grade (grade 6, 7, or 8)~~
179 ~~students, including charter schools, with fewer than 75 percent of its students~~
180 ~~reading at or above grade level in grade 6, grade 7, or grade 8, defined as~~
181 ~~scoring at level 3 or above on the FCAT during the prior school year, must~~
182 ~~incorporate by October 1 of each year a rigorous reading requirement for reading~~
183 ~~and language arts programs as the primary component of its school improvement~~
184 ~~plan.~~

185
186 d. Although the school improvement plan is for one year, SACs are also
187 encouraged to adopt long-range goals and objectives that cover a multiyear time
188 frame.

189
190 e. The school improvement plan must have annual objectives based on an annual
191 analysis of student achievement and other school performance data.

192
193 f. The individual school and its SAC shall submit the school improvement plan to
194 the Superintendent/designee by the last Friday in October of each year (absent
195 extenuating circumstances) or as required by the Florida Department of
196 Education, whichever is earlier.

197
198 g. The Superintendent shall submit the school improvement plan for each school to the Board for approval by December
199 31st of each year, and the Board must annually approve and require implementation of a new, amended, or continuation
200 school improvement plan for each school in the district, as required by Fla. Stat. § 1001.42(16)(a).

201
202 h. The Board shall provide school improvement funds to schools for developing and implementing school improvement plans
203 pursuant to Fla. Stat. § 1001.42(16)(f).

204
205 i. Such funds shall include those funds appropriated for the purpose of school improvement pursuant to Fla. Stat. §
206 24.121(5)(c).

- ii. School improvement funds provided under Fla. Stat. § 24.121(5)(c) may be expended only on programs or projects selected by the SAC for enhancing school performance through development and implementation of a school improvement plan. As stated in § 24.121(5)(c), the school principal may not override the recommendations of the SAC on use of these funds.
 - iii. These moneys may not be used for capital improvements, nor may they be used for any project or program that has a duration of more than one (1) year; however, as allowed by § 24.121(5)(c), a SAC may independently determine that a program or project formerly funded under this paragraph should receive funds in a subsequent year.
8. Waiver of Local or State Regulation.-- Should a school identify a local or state regulation that presents a barrier to improved student achievement and implementation of the school improvement plan, the SAC may submit a request to the District Waiver Committee (DWC).
- a. The DWC may recommend a waiver of School Board Policy to the Board pursuant to Fla. Stat. § 1001.42(17)(b), as long as the waiver would not be inconsistent with the underlying state statutes or State Board of Education rules.
 - i. Following a vote of the SAC, the principal submits the waiver request for review to the area superintendent/designee and Superintendent/designee.
 - ii. The Superintendent/designee forwards the waiver to the District Waiver Committee. The Committee consists of:
 - A. Principals selected by their respective Principals Associations;
 - B. Department representation as appointed by the Superintendent and as appropriate for the waiver;
 - C. The Classroom Teacher's Association (CTA), with representative membership on the District Waiver Committee, shall review each waiver pursuant to the standards set forth in the CTA Bargaining Agreement, to determine if the waiver constitutes a change in employee hours, terms or conditions of employment. The CTA Board of Directors is the governing body authorized to accept waivers, reject waivers, or accept waivers with conditions if they require a waiver of contract standards.
 - D. Representative from The Association of Educational Secretaries and Office Personnel (AESOP);
 - E. Representative from National Conference of Firemen and Oilers (NCFO).
 - b. The DWC will review and make recommendations to the Superintendent/ designee on each waiver, considering the following factors:
 - i. Whether the waiver of School Board Policy under Fla. Stat. § 1001.42(17)(b) is possible without incurring inconsistency with the underlying state statutes or State Board of Education rules;
 - ii. Whether the waiver is focused on maximizing student outcomes;
 - iii. Whether the waiver is based on research and best practices.
 - c. If the waiver is not recommended, the principal and SAC will be notified by the Superintendent/designee of any issues or questions the District Waiver Committee has regarding the waiver and will have an opportunity to amend the waiver for further consideration.
 - d. If the waiver of Board Policy is recommended by the DWC, the Superintendent may submit the waiver request(s) to the Board for approval.
 - e. If the requested waiver of Board Policy would be inconsistent with the underlying state statutes or State Board of Education rules, the DWC may transmit the request to the Charter District Advisory Committee as a possibility for the School Board to pursue as an exemption under charter district status.

264 9. Training and Support

- 265
- 266 a. Training, support, and written materials shall be available for SAC members that
- 267 include state and local requirements for SACs, roles and responsibilities of SAC
- 268 members, use of data for decision-making, the budget process, and timelines for
- 269 developing the school improvement plan. All SAC members are encouraged to
- 270 review the SAC materials posted by on the web site of the District's Office
- 271 Department of School Improvement at www.palmbeach.k12.fl.us/
- 272 schoolimprovement/sip_sac.htm.
- 273
- 274 b. If a SAC member or other member of the school community has a concern about
- 275 the SAC's operation or compliance with this Policy, such person may contact the
- 276 District's Office Department of School Improvement. The Office Department of
- 277 School Improvement will coordinate resolution of the issue, with the advice and
- 278 assistance of appropriate sources as needed, such as the principal, area
- 279 superintendent, Chief Academic Officer, or Department of Legal Services.
- 280

281 10. School Budget

- 282
- 283 a. Each SAC shall assist in the preparation of the school's annual budget, which is prepared by Budget Services, as required
- 284 by Fla. Stat. §§ 1001.452(2) and 1008.385(1).
- 285
- 286 b. To facilitate this budgeting process, the SAC will have the school's previous year's June 30th Budget Status Summary
- 287 with supporting documentation, the current fiscal year's Budget Status Summary with supporting documentation, and the
- 288 proposed fiscal year's budget, as provided by Budget Services.
- 289
- 290 c. The school's current fiscal year's Budget Status Summary, prepared by Budget Services, will be provided to the SAC on
- 291 an annual basis in accordance with Fla. Stat. § 1001.452(2) and 1008.385(1).
- 292
- 293 d. Information regarding other resources of the school, such as internal accounts, will be shared with the SAC on an annual
- 294 basis for information purposes only.
- 295
- 296 e. If requested by a majority vote of the SAC, quarterly reports of the current year's budget by project, function and object,
- 297 including a percentage comparison of amended budgets spent to date, will be provided by Budget Services. These
- 298 reports can be used to compare the current year's budget with the previous year's budget.
- 299

300 11. District-Wide Meetings

- 301
- 302 a. The Superintendent shall schedule at least two (2) district-wide meetings regarding school improvement and SACs each
- 303 school year. One meeting in the fall will provide school improvement training for SAC members, and one meeting in the
- 304 spring will provide school improvement training for SAC members and also provide an opportunity for SAC members to
- 305 give input on school improvement to the Superintendent/designee.
- 306
- 307 b. These meetings are intended for SAC members, Reform Panel members— as established by the CTA Collective
- 308 Bargaining Agreement, and School Board members to exchange programs, ideas, and other information on school
- 309 improvement.

- 353 1. ~~Develop and review the implementation of the School Improvement Plan.~~

Representation and Membership

In accordance with Florida Statute 1001.452, which outlines the establishment of SACs:⁴

~~Section 1: The membership shall be representative of the student body and community served by the school. The SAC shall have an appropriately balanced number of teachers, parents, support employees, students, business and community members.~~

~~Section 2: The majority (50% + 1) of the members of the SAC shall be non-school employees.~~

~~Section 3: The SAC membership shall be *appropriately* balanced.⁵~~

Article IV

Membership Selection

~~Section 1: The SAC membership shall be constituted as follows:~~

~~1. Parents, teachers, students and support employees will be elected by their respective groups through an election in which all parents have an opportunity to participate.~~

~~i. Teachers shall be elected by teachers;~~

~~ii. Education support employees shall be elected by education support employees;~~

~~iii. Students, when appropriate, shall be elected by students; and~~

~~iv. Parent members shall be elected by parents in general, with all parents having an opportunity to participate in voting for any parent on the ballot.~~

~~2. There will be wide notice of SAC vacancies and elections through methods to include school marquee, school newsletter, PTA/PTO meetings, announcements at Open House, etc. The names of parents willing to serve on the SAC will be listed on a ballot which will be distributed to all parents who will vote on the nominees.~~

~~3. Business and community members will be selected based on the new procedures adopted by the School Board.~~

~~4. Replacement members shall be elected by appropriate constituencies.~~

~~5. The principal is automatically a member by legal mandate.~~

~~Section 2: Elections shall be held in [month] of each year and the installation of new members shall follow immediately.⁶~~
