

**FIRST AMENDMENT TO THE AGREEMENT  
BETWEEN THE SCHOOL BOARD OF PALM BEACH COUNTY AND  
LIFE SKILLS CENTER OF PALM BEACH, INC. (LIFE SKILLS CENTER-GLADES AREA)**

The School Board of Palm Beach County, Florida ("School Board") and Life Skills Center of Palm Beach County, Inc. operating as Life Skills Center – Glades Area ("Charter School"), hereby agree to amend the Agreement entered between the parties on or before **August 16, 2006**, as follows:

1. On or about **July 16, 2006**, the School Board received written correspondence from the Charter School, a copy of which is attached as Exhibit "A" to this Amendment, requesting that its opening date be deferred until **January, 1, 2007**.
2. The request was based upon the fact that a facility would not be available until that date.
3. Therefore, the following provisions in the Charter Agreement will need to be extended based on the deferred opening date, specifically:
  - a. Section 12.0 – CRITERIA FOR ADMISSION, Paragraph D ;
  - b. Section 23.0 - FACILITIES, Paragraph D ;
  - c. Section 23.0 – FACILITIES, Paragraph F ;
  - d. Section 26.0 – INDEMNIFICATION AND INSURANCE, Paragraph I ; and
  - e. Section 30 – ARTICLES OF INCORPORATION AND GOVERNANCE STRUCTURE, Paragraph J.
4. In the event of any conflict between the terms of the First Amendment and the Charter Agreement, the terms of the First Amendment shall control.
5. The Superintendent is authorized to take administrative action on delayed or deferred openings of Charter Schools.

IN WITNESS WHEREOF, the Parties hereto agree to this First Amendment to be effective on the date last signed by the Parties.

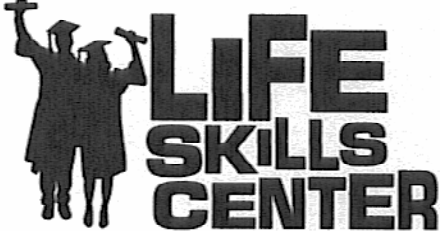

Dear Mrs. Edwards:

Please accept this correspondence as a request of Life Skills Center – Glades Area to delay the opening of our proposed charter school until the second semester of school year 2006-2007.

We are currently pursuing several locations for the school, but based on our current progress in negotiating a lease and going through the zoning process, we don't believe that we will be able to open for the start of the 2006-2007 school year.

The applicant acknowledges that it will be required to provide to The School Board an updated budget and to update any other portions of the application that may need adjustment due to this requested extension and delay. This updated information will be provided to the school district prior to the resumption of charter school agreement negotiations. It is further acknowledged that the school district will require a reasonable period of time to review any updated information before proceeding with charter agreement negotiations.
