

RESOLUTION

DECLARING STRUCTURES LOCATED ON PROPERTY
TO BE ACQUIRED BY THE SCHOOL BOARD TO BE UNNECESSARY
FOR EDUCATIONAL PURPOSES, SURPLUS AND WITHOUT COMMERCIAL VALUE

WHEREAS, the Real Estate Services Department of the School District of Palm Beach County, Florida, having reviewed the status of certain structures to be owned by the School Board located on land to be acquired by the School Board to be used as part of the New Suncoast High School Campus; and
