#### Introduction to SES

- ☐ Tutorial services provided in reading or math by state-approved agencies for eligible students
- ☐ Students must be eligible for Free/Reduced price meals and Level 1 or 2 on assessment tests
- ☐ Mandated as a choice by NCLB at Year 3 SINI schools

#### Introduction to SES (cont.)

- □ Parents must choose the provider
- ☐ The state sets the maximum amount per pupil that can be paid to the provider
- □ For FY06, the amount per pupil was \$1258.93
- □ SES is funded from the mandatory 20 percent set aside for districts having Schools in Need of Improvement (SINI)

#### Timeline for SES

- □ In April 2005 students at 71 schools received letters inviting participation in NCLB Choice with transportation or SES. 55,000 letters were mailed
- □ Following the receipt of the 2005 FCAT data, 12,500 students at 47 schools received letters of SES eligibility
- □ 1,993 students received services in FY06

#### Parental Outreach

- □ April 2005 letters mailed home
- □ August 2005 letters mailed home
- □ August 2005 letters in backpacks
- □ August 2005 posters in each school; information on front counters
- □ August 2005 articles in local newspapers: Palm Beach Post and Sun Sentinel
- □ September 2005 six provider fairs throughout the county
- □ School outreach to parents
  - Community language facilitators
  - Parent liaisons
  - Teachers
  - Front office staff

#### **School Outreach**

- □ An informational meeting for principals was held in July 2005
- ☐ Each school selected an SES contact person
- ☐ The SES contacts attended six informational meetings throughout the year
- ☐ The SES contacts assisted with enrollment of students

#### **Provider Outreach**

- □ A meeting was held with all state-approved SES providers in August 2005
- □ All providers signed School District contracts
- ☐ Six provider fairs were scheduled
- □ Cayen Systems training was conducted
- □ We urged providers to call with questions or concerns
- □ We monitored providers serving our students

### Oversight of SES

- ☐ Monitoring of SES services was conducted during random site visitations
- □ Parent surveys were conducted to monitor online providers
- □ Parent satisfaction surveys were completed
- □ Principal surveys were completed
- □ Student achievement data was reviewed

#### SES for FY07

- □ There are 33,109 eligible students in 64 schools for FY07
- □ The maximum per pupil allocation set by the state for FY07 is \$1,212
- □ Seven provider fairs were held throughout the county; 422 families attended the fairs
- □ Florida Stat. §1001.43 has mandated that SES begin by October 15<sup>th</sup>

#### SES for FY07 cont.

- □ There are 34 eligible providers for Palm Beach County. The state recently conducted a second round for provider applications; there were an additional 9 providers approved to serve in our county.
- □ We worked overtime to input students into Cayen Systems in order to meet the October 15<sup>th</sup> deadline.

## SES for FY07 cont.

- ☐ There are currently 6600 students enrolled and placed
- ☐ There are approximately 500 students on a waiting list
- ☐ Funding is available to provide tutoring to 4826 students
