

**SECOND AMENDMENT TO THE AGREEMENT  
BETWEEN THE SCHOOL BOARD OF PALM BEACH COUNTY AND  
GULFSTREAM GOODWILL CAREER ACADEMY, INC.**

The School Board of Palm Beach County, Florida ("School Board") and Gulfstream Goodwill Academies, Inc. operating as Gulfstream Goodwill Career Academy Charter School ("Charter School"), hereby agree to amend the Agreement entered between the parties on or before December 13, 2006, as follows:

1. The School Board entered into a five (5) year Charter Agreement with Gulfstream Goodwill Career Academy, Inc. on April 22, 2004.
2. On or about **October 26, 2006**, the School Board received a written request to amend the Charter Agreement changing the school staff from private employees to public employees so that they can participate in the Florida Retirement System. A copy of that written request is attached hereto as Exhibit "A".
3. Whereby, **Part V: PERSONNEL, Section 27.0 Employee Status, Staff, and Governing Board, Subsection A** is hereby amended to state that the "Employees shall not be private employees, rather they shall be public employees eligible to participate in the Florida Retirement System."
4. In the event of any conflict between the terms of the Second Amendment and the Charter Agreement, the terms of the Second Amendment shall control.
