AMENDMENT TO THE CONTRACT BETWEEN THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA

("School Board")
AND

PALM BEACH MARINE INSTITTUE, INC. ("Marine Institute")

On this _____ day of _____, 200__, in addition to the terms and conditions set forth in the Contract Between The School Board of Palm Beach County, Florida, and Palm Beach Marine Institute, Inc., dated the 1st day of July, 2006 (the "Contract"), for the provision of alternative programs of education, training, and related services for students in the Palm Beach Marine Institute Program, the following Amendment is hereby made a part of the Contract. To the extent a conflict exists between any of the terms and conditions of the Contract (including any attachments and exhibits thereto) and any of the terms and conditions of this Amendment, this Amendment shall govern.

In consideration of the promises herein and other good and value consideration, the Marine Institute and School Board agree as follows:

The Contract is amended and modified hereby to add that the Marine Institute shall reimburse the School Board for one full-time School District ESE teacher providing ESE services to the Palm Beach Marine Institute Program. Specifically, paragraph F of the STUDENT ELIGIBLITY section of the Contract shall be stricken and replaced with the following paragraph:

"STUDENT ELIGIBILITY, Rule 6A-6.05281(1), Florida Administrative Code.

- (F) The Marine Institute shall provide a minimum of one Exceptional Student Education (ESE) certified teacher to develop, implement and determine mastery of the IEP goals for the exceptional education students. If the Marine Institute has no eligible ESE certified teachers, the Alternative Education Director will recommend a qualified School District ESE certified teacher to provide the necessary services to ESE students. The Marine Institute will absorb the costs incurred by the School Board to meet the requirements of the ESE certified teacher. The cost will be based on the School District of Palm Beach County School Center Standard Salaries for FY 2007 total salary and fringe benefit rate for a 250 duty day teacher. The FY 2007 250-duty-day-teacher rate is \$80,144.00. The Marine Institute shall reimburse the School Board on a monthly basis."
- 2) Except as otherwise modified herein, all of the terms and conditions of the Contract are hereby ratified and remain in effect without revision.
