1) Pages 2 and 6 shall be amended such that the Contract end date sl	hall be extended from December 22, 2006 to June 30, 2007, or until
appropriate discharge can be planned, not to exceed June 30, 2007.	
2) Page 2, Section 2 shall be amended to reflect that the amount of t	he Contract shall be increased by \$66,150 from \$14,700 to an
annualized cost of up to \$80,850 to cover cost of 189 additional day	ys or until appropriate discharge can be planned, not to exceed 189 days
in residential facility as recommended by team following review of	psychiatric evaluation completed November 14, 2006.
3) This Agreement shall be amended or modified only in writing an	d executed by both parties. This Agreement may be terminated by
either party upon written notice of thirty (30) days. If either party to	erminates for convenience herein it shall not be liable for breach of
contract, lost profits or other such damage whether consequential or	inconsequential. The thirty (30) day notice does not require the Board
to pay the per diem rate for those days in which the student is not pr	resent and attending the program.
4) To the extent a conflict exists between any of the terms or condi	tions of the Contract (including any attachments and exhibits thereto)
and any of the terms and conditions of this First Amendment, this F	irst Amendment shall govern. Except as otherwise modified herein, all
of the terms and conditions of the Contract, are hereby ratified and	remain in effect without revision.
