Children and families served through the afterschool programs at both Egret Lake and Galaxy elementary schools will benefit by the following: 1- Afterschool programs provide a safe and nurturing environment for young children of working parents. Most of these parents need the free/reduced fee care that is offered as they are low-income, working poor and marginally employed. Parents can be relieved of the worry and concern about the quality and consistency of the care being provided and this increases their opportunties of maintaining employability. 2- The importance of literacy proficiency is welldocumented, particularly for young students. It is shown that in grades K-3 students are learning to read and from then on are reading to learn. If students do not learn to read on grade level by the third grade they struggle throughout their academic years and are rarely able to catch up without intensive intervention. The afterschool programs are an extension of the school day and this program will enhance and improve special programs aimed at improving proficiency for low level readers. At Egret Lake Elementary 46% of third graders; 52% of fourth graders and; 47% of fifth graders read below grade level. 12% of their students are Limited English Proficient. At Galaxy Elementary 63% of third graders; 63% of fourth graders; and 48% of fifth graders read below grade level. 24% of their students are Limited English Proficient. The investment in literacy improvement has untold benefits as it will improve academic performance in all subject areas; increase access to higher education or advanced skill training and prepare young students for a more certain future.

Grant Purpose

This grant's purpose is to provide Reading Fluency Libraries to two targeted District afterschool programs serving up to 250 students in each program. The targeted programs do not generate sufficient funds from their existing fee-based budgets to provide this program component. Targeted programs will serve populations with more than 75% free and reduced lunch socioeconomic status. The grant would fund materials (books, audiobooks, and audio equipment) and a part-time "fluency librarian" for each of the targeted afterschool programs.

If funded, materials and equipment would be purchased for each of the targeted programs. Each program would be provided with funds to hire a part-time afterschool staff member who would be trained and coached by District staff to facilitate the integration of a "Finding Fluency" component into the existing afterschool program. District staff have developed training and technical assistance

Proficiency in reading is positively correlated to success in education as well as to successful entry into higher level education, the workforce, and to productive and responsible citizenship. An essential component of reading proficiency is fluency, the ability to read accurately and at an appropriate rate that aids comprehension of text. An effective strategy for building reading fluency is exposure to a variety of fiction and nonfiction texts with frequent opportunities for self-selection of reading materials and time for independent reading. A second research-based strategy for facilitating reading fluency is the provision of models of reading fluency, specifically, providing opportunities for the developing reader to hear text read with appropriate intonation, rate, and accuracy while the reader follows (or reads along with) the written text.

School Age Child Care programs of the School District of Palm Beach County provide afterschool programming for approximately 16, 000 students in 92 elementary schools throughout the district. In addition to safe, nurturing child care, these programs seek to complement the regular school day by providing academic enhancements during the afterschool program. This project will allow the District to provide and support additional program enhancements in higher needs targeted afterschool programs.

Grant Outcomes

- 1. Students enrolled in targeted afterschool programs will have increased opportunities (up to five per week) for interacting with a variety of texts in afterschool settings.
