ADDENDUM TO CHARTER AGREEMENT BETWEEN THE SCHOOL BOARD OF PALM BEACH COUNTY & LAKESIDE ACADEMY CHARTER SCHOOL, INC. DATED JUNE 28, 2006

Area of Deficiencies that must be corrected by May 1, 2007 for <u>Lakeside Academy</u> <u>Charter School, Inc.</u> to be eligible for a new contract:

- 1. The Charter School must increase enrollment to 100 students by May 1, 2007 which will be verified by the February 2007 FTE Survey. This will help to increase FTE Revenue which will be a benefit to the student population.
- 2. The Charter School must exhibit sufficient data that the student population is making a year's worth of academic growth during a year's time period from August 2006 through June 2007. This shall be evidenced by the Sunshine State Standard Diagnostics, the Common Assessments, Running Reading Records, the Scholastic Reading Inventory (SRI) and the 2006-2007 FCAT scores.
- 3. The Charter School must provide ESE services as documented on the students' IEPs, follow ESE procedures for eligibility, maintain consultation logs, and provide consistent Speech and Language services to eligible students. This will be evidenced by the ESE District Resource Teacher on her bi-monthly site visitations to the Charter School. This will be evidenced by matrix scores, mandatory ESE forms, and consultation logs.
- 4 The Charter School must maintain a minimum number of three (3) Board Members, as stated in the By-Laws, on a monthly basis. Governing Board Minutes must be sent to the Charter School Office by the last day of the month. The Charter School Department is to be timely notified of any and all changes of Board Members.
- 5. The Charter School must present to the District's Accounting Department a Capital Project Plan for future expenditures by July 30, 2006.
- 6. Failure to comply with the above stated conditions/issees shall constitute a "good ' cause" basis for non-renewal and immediate termination of the Charter Agreement as stated in Section 1002.33 (8) (d), F.S.

This Addendum is entered between the parties and incorporated into the Charter Agreement on the date last executed by all parties.
