NARRATIVE

1. Project Abstract or Summary

Over 10% of Palm Beach County students use tobacco which interferes with academic achievement and is associated with many self-defeating behaviors. The project has two goals focused on teacher training and reduction in tobacco use: Goal 1: A cadre of skilled tobacco prevention educators will be trained to use Channing Bete and CDC's Scene Smoking lessons with accompanying guides and student workbooks to teach tobacco prevention to their students. Goal 2: To reduce the incidence of use of tobacco by students in the participating schools. The proposed Project will offer Prevention Education training to teachers though on-line courses. The program proposed will provide two Blackboard on-line courses, one each for elementary and secondary teachers. The classes for elementary teachers will use Channing Bete's Tobacco Prevention materials. The course for secondary teachers will use Channing Bete materials as well as the Scene Smoking course from the CDC for high school teachers. Teachers will be given the consumable workbooks and teacher guides to deliver the program to their students. The targeted teachers are: 60 Elementary 4th and 5th grade teachers, as well as PE, SAI (Supplemental Academic Instruction) and other interested teachers or guidance counselors; 7 Middle School Health Teachers and 11 PE teachers; 12 Family Consumer Science Teachers and 10 PE teachers. The project will be evaluated by a professional, highly experienced evaluator, Candace Lacey, Ph.D.

2. Project Need 20 points


Describe the need for the project and provide supporting data as evidence.

Tobacco use by Palm Beach County students interferes with their academic achievement.


"Smoking is statistically associated with depression, anxiety, attention deficit hyperactivity disorder, and other psychiatric disorders...Smoking is often associated with poor school performance, low aspirations, alcohol and other drug use, school absences, and anticipated dropping out. Nicotine is frequently the first substance of abuse used by children and youth. Those who use it are 15 times more likely to progress to other drug use than those who have never smoked...Personal characteristics correlated with child and teen cigarette smoking include low self-esteem, poor self-image, low perceived self-efficacy, susceptibility to peer pressure, novelty seeking and rebelliousness, ignorance of smoking-related adverse effects, depression, and anxiety (p.794-796)." (Committee on Substance Abuse, "Tobacco's Toll: Implications for the Pediatrician." Pediatrics, 107.4 (2001), pp. 794-798).

Over 10% of Palm Beach County students use tobacco according to the Florida Youth Substance Abuse Survey 2006 Palm Beach County Report (FYSAS): 3.7% of middle school students and 14.9% of high school students in Palm Beach County reported using tobacco within the past 30 days (Florida Youth Substance Abuse Survey-FYSAS- 2006 Palm Beach County Report).

According to the 2005 Youth Risk Behavior Surveillance (YRBS) Palm Beach County data, almost 13% of high schools students smoke. Information about current usage of tobacco and use at schools, which demonstrate a compelling need for increase tobacco prevention education, is outlined in the tables below.

According to the YRBS, 53% of these students tried to quit using tobacco. The School Environment Safety Incident Report (SESIR) indicates that there has been an increase in tobacco incidents at school from 1.99 per 1000 in 2004-2005 to 2.05 incidents per 1000 in 2005-2006. Continued increase over five years could result in up to 5.05 incidents per 1000.

Suspension data shown in Table 3 indicates how many middle and high schools students were suspended.

The proposed Tobacco *Prevention and Intervention Teacher Training Project* will offer Prevention Education training to teachers though on-line courses. The program proposed will provide two Blackboard on-line courses, one each for elementary and secondary teachers. The classes for elementary teachers will use Channing Bete's Tobacco Prevention materials. The course for secondary teachers will use Channing Bete materials as well as the Scene Smoking course from the CDC for high school teachers. A total of 100 teachers will be trained in the two courses. The targeted teachers are:

- 60 Elementary 4th and 5th grade teachers, as well as PE, SAI and other interested teachers or guidance counselors (who teach 4th and 5th graders)
- 7 Middle School Health Teachers and 11 PE middle school teachers
- 12 Family Consumer Science Teachers and 10 PE high school teachers

The teachers were selected based on knowledge of requests for training, and discussion with teachers and the district staff overseeing the identified subject areas.

The project helps the District meet the Sunshine State Health Education Standards and Benchmarks, identified below and the seven recommendations from the Centers for Disease Control and Prevention (CDC) for effective school-based strategies to prevent youth tobacco use (Morbidity and Mortality Weekly Report, February 25, 1994 (2/25/94; 43[RR-2]; 1-18).

CHANNING BETE:

WHO KNEW? THE SMOKE-FREE ISSUE for ages 9-11, which will be geared to 4th and 5th graders. It meets the following standards and benchmarks.

Health Literacy: Standard 1 The student comprehends concepts related to health promotion and disease prevention. (HE.A.1.2) Benchmarks 2, 3, 4, 5, 9

Standard 2: The student knows how to access valid health information and health-promoting products and services. (HE.A.2.2) Benchmarks: 2, 3, 4

Responsible Health Behavior Standard 1: The student knows health-enhancing behaviors and how to reduce health risks. (HE.B.1.2) Benchmarks: 1,2,4,5

ON BLOWING OFF SMOKE for ages 15-17 will be presented to the high school teachers. The course meets the following standards and benchmarks:

Health Literacy Standard 1 ((HE.A.1.4): Benchmarks 1-8; Standard 2 (HE.A.2.4): Benchmarks 1-6; Responsible Health Behavior Standard 1 (HE.B.2.4) Benchmarks 1, 2, 4; Standard 2 (HE.B.2.4): Benchmarks: 1-4; Standard 3 (HE.B.3.4): Benchmarks: 1,2,3,4,5,7; Advocate and Promote Healthy Living Standard 1 (HE.C.1.4): Benchmarks: 1-6; Standard 2 (HE.C.2.4): Benchmarks: 1-6.

SCENE SMOKING from the CDC:

The Scene Smoking course from the CDC is geared towards high school and college students. The lessons for high school students will be taught to the teachers. SCENE SMOKING meets the SSS for Health Education: Health Literacy 9-12 Standard 1 (HE.A.1.4): Benchmarks 1-8; Standard 2 (HE.A.2.4): Benchmarks 1,2,3,4,6; Responsible Health Behavior Standard 1 (HE.B.2.4) Benchmarks 1-3; Standard 2 (HE.B.2.4): Benchmarks: 2-4; Standard 3 (HE.B.3.4): Benchmarks: 1,2,3,4,7; Advocate and Promote Healthy Living Standard 1 (HE.C.1.4) Benchmarks: 1,3,4,5; Standard 2 (HE.C.2.4): Benchmarks: 1-5.

The lessons can be used in Health, Life Management, Social Studies, Media, Ethics/Government and/or Physical Education and meets standards in each of these academic areas, as outlined in the guides.

3. Project Design and Implementation 20 points

Describe the measurable objectives, activities, and timeline for the project.

The project has two goals focused on teacher training and reduction in tobacco use.

Goal 1: A cadre of skilled tobacco prevention educators will be trained to use Channing Bete and CDC's Scene Smoking lessons to teach tobacco prevention to their students.

Program Objective: 1.1 By Oct. 1, 2007, an on-line course for elementary teachers, using the Channing Bete grades 4-5 materials, will be developed.

Activities: 1.1.1 The Consultant in the Prevention Center, with the assistance of contracted experts in prevention and social marketing, experienced prevention staff in the Prevention Center, The Education Network (TEN) and the Department of Educational Technology will create the course that teachers can take for 30 component points that can be used for teacher recertification upon completion and follow up. The course will include: video presentations, demonstration of lessons, PowerPoint, Pre-Post questionnaires, quizzes, and evaluations.

Program Objective: 1.2 By November 1, 2007, an on-line course for secondary teachers, using the using the Channing Bete materials for grades 6-8 and the Channing Bete and CDC Scene Smoking for grades 9-12, will be developed.

Activities: 1.2.1 The Consultant in the Prevention Center, with the assistance of contracted experts in prevention and social marketing, other experienced prevention staff in the Prevention Center, TEN and the Department of Educational Technology will develop the course that teachers can take for 30 component points that can be used for teacher recertification upon completion and follow up. The course will include: video presentations, demonstration of lessons, PowerPoint, Pre-Post questionnaires, quizzes, and evaluations.

Program Objective 1.3 By Oct. 1, 2007 The evaluator will create required survey and evaluation implementation strategies.

Activities 1.3.1 Survey and evaluation strategies will be created.

Program Objective 1.4 By May 1, 2008, a total of 100 Elementary, Middle School and High School Teachers will have completed an on-line Blackboard course on Teaching Tobacco Prevention lessons.

Activities: 1.4.1The courses will be advertised and marketed to teachers through email, announcements, School District website notices, District "Focus" on-line newsletter, school newsletters, posters, School

Health Advisory Committee (SHAC), Safe and Drug-Free Schools Advisory Council, and Character Education Committee.

- 1.4.2 On-line enrollment will be developed to include all needed information: personal contact information, grade taught, numbers of students, etc.
- 1.4.3 A sample of curriculum materials will be sent to the enrolled teachers.
- 1.4.4 The courses will "go live" and be offered through March, in time for Brown Ribbon Month, the anti-tobacco campaign in Palm Beach County, which is in April.
- 1.4.5 Once the teacher has completed introductory sessions of the on-line training, the consumable materials will be sent to him or her to use to teach his students. Use of the materials in the classroom is required for receipt of the 30 staff development points.
- 1.4.6 Teachers will be given assignments, quizzes, and evaluations. Their participation will be monitored by the consultant through on-line course software and verbal, email and on-site assistance.
- Goal 2: To reduce the incidence of use of tobacco by students in the participating schools.

Program Objective 2.1: By June 1, 2008, up to 10,890 students of the trained teachers will receive grade level appropriate tobacco prevention lessons, thereby increasing their knowledge about the effects of tobacco, improving their media literacy, and use of effective refusal skills.

Activities: 2.1.1. The trained teachers will teach the tobacco prevention programming to their students using the identified curriculum materials (Channing Bete for grades 4-5 and 6-8), Channing Bete and CDC for grades 9-12.

2.2.2 Students' increased knowledge about the effects of tobacco, improved media literacy, and use of effective refusal skills will be documented through survey completion.

4. Evaluation 20 points

Describe the instruments and method(s) for evaluating the project.

Goal 1: A cadre of skilled tobacco prevention educators will be trained to use Channing Bete materials and CDC's Scene Smoking lessons to teach tobacco prevention to their students.

Impact/Outcome: Ninety percent of trained teachers will demonstrate increased knowledge of how to use Channing Bete materials and CDC's Scene Smoking lessons to teach tobacco prevention.

Evaluation Instruments and Methods

Prior to the beginning of the course, at the end of each lesson and at the end of the on-line course, teachers will complete a series of instruments. A pre-post knowledge assessment will be implemented to determine skill attainment. In addition, the post assessment will include questions regarding satisfaction, and recommendations for future training. A series of content-based quizzes will be required. To ensure that content knowledge has effectively been delivered, teachers will be unable to proceed from lesson to lesson until the correct answers have been provided. The number of teachers who begin and successfully complete the on-line course will be reported. A random sample of teachers who do not complete the course will be contacted to determine why they withdrew from the program.

Goal 2: To reduce the incidence of use of tobacco by students in the participating schools.

Impact/Outcome:

Ninety percent of trained teachers will utilize Channing Bete and CDC materials to teach tobacco prevention lessons.

There will be a statistically significant decrease in the number of students reporting their tobacco use prior to the program and at program completion.

After participating in the program, students will increase their knowledge of the harmful effects of tobacco use and effective refusal strategies.

Evaluation Instruments and Methods

Tobacco Prevention Lesson Usage Forms will be kept by participating teachers. This Form will document lesson delivery and number of students impacted by the lessons. In addition, a random sample of participating classrooms will be observed to assess lesson delivery and fidelity of implementation.

incidents will be measured by the Student Information Series Incident Detail (SISID) and SESIR).

A random sample of students at participating schools will complete a pre and post survey measuring knowledge of the harmful effects of tobacco use and effective refusal strategies. The survey will be administered using Response Card RF. (This technology also helps with Social Norming because students see other students' anonymous responses). Data will be analyzed using independent sample t-tests.

As part of the curriculum, students will complete an anonymous survey asking them to report their tobacco use 30 days prior to the program implementation. At the end of the program, the same survey will be completed by the students reporting their tobacco in the past 30 days. Using power analysis, a random sample of surveys will be selected for analysis from participating schools. Scores will be compared pre and post with statistical significance and effect size reported.

5. Support for Strategic Imperatives 10 points

Describe how the proposed project will address the reading initiative. Incorporate one or more of the Florida State Board of Education (SBE) Strategic Imperatives.

The project supports *Just Read! Florida* and the on-line course will include web links and additional reading suggestions. The District places great importance on emphasizing reading in all content areas and

staff development activities must be aligned to student achievement. Increased literacy is the School District's number one goal. The on-line course will teach teachers to use the curricula for their students. In addition to being aligned with Sunshine State Standards, each lesson can be integrated into other courses with the standards described as follows.

Scene Smoking: Writing – Use general writing skills and strategies, stylistic and rhetorical aspects of writing, grammatical and mechanical conventions, and information for Research purposes; Listening and Speaking – Use listening and speaking strategies for different purposes; Technology Communications Tools – Use a variety of media and formats to communicate information and ideas effectively to multiple audiences.

Channing Bete: Materials for students are individual magazines of up to 25 pages each, which include: writing assignments, word plays, research activities, interviews, math problems, creating ads, etc.

The Prevention Center created the most successful on-line Blackboard course in the District to date on Character Education, with three times as many registrants as all previous courses. The lessons learned from this success are incorporated into the plan described here.

- 1. Web-based Marketing: The program will be advertised on the Department of Safe Schools' Prevention Center website and on the District's home page if possible. Registration for the program will be on-line. Links from Staff Development, Educational Technology and TEN will be requested.
- 2. Announcements: A flyer will be created and disseminated to school personnel throughout the District to advertise the program. Posters will be made and distributed to each school. Notices will be placed in school newsletters and the District on —line newsletter, *Focus*.

The program will be announced at the quarterly SDFS Advisory Council and monthly Character Education Committee and School Health Advisory Committee meetings.

In October, the flyer will be placed in the Red Ribbon Week, the national anti-drug use campaign, packets that go to all the schools with instructions for distribution.

Emails announcing the on-line course will be sent to all Health teachers, 4th and 5th grade teachers, Family Consumer Science Teachers, PE teachers, guidance counselors, and the district supervisors related to these curriculum areas. Related School District departments may be asked to create links: TEN and Staff Development.

3) Word of Mouth: The Consultant will actively review course participation and provide assistance and monitoring to teachers when they implement the program into the classrooms. The quality of the course, the quality of the materials and the support will lead to participants sharing with other teachers about the course.

Consultant: \$19,493 to create 2 Blackboard courses to create 2 on-line training courses; coordinate on line registration; create flyers; monitor program implementation on site at schools; and monitor and record usage, enrollment, program completion at \$26/hour.

8. Community Collaboration and Partnerships 10 points

Existing community expertise and resources will be used to help create the course. Their input will be obtained through existing relationships and participation in the SDFS Advisory Council, SHAC, and Character Education Committees. TEN will help create the courses by taping interviews and presentations about tobacco prevention. Educational Technology assists with the online course development. Other district departments will be informed through the monthly Multidepartmental Meetings.

Local community and other experts will be asked to be filmed for parts of the training. The Prevention Center collaborates with the Palm Beach County Substance Abuse Coalition on many activities to promote drug-free living, awareness about drug use including alcohol and tobacco, and educational forums. The Coalition will support implementation of the proposed project by: a) helping to provide educational materials; b) making Peer Educators available to help teachers teach the lessons; c) providing student materials for Brown Ribbon Month, which supports the training that teachers receive. This effort will help meet both project goals. The materials can assist teachers to learn about tobacco prevention. The Peer Educators can help students increase their knowledge and refusal skills. Jennifer Harris, Regional Tobacco Prevention Coordinator with the Florida Department of Health, will provide materials to help provide additional information to teachers about tobacco use. She will be interviewed as part of the course, focusing on media literacy and social marketing. Increased media literacy is on of the objectives of the second goal of the grant, to reduce tobacco use by students. She will also provide information about Students Working against Tobacco (SWAT) so that teachers will encourage their students to participate at the secondary level. The Tobacco Specialist in the Department of Health will assist with the objectives to create the course and help teachers implement the program by providing materials and promotional items and helping by having a representative expert videotaped for the course. Letters of support are attached.

The Assistant Director in the Prevention Center sits on the monthly School Health Advisory Committee. She will present the proposal at the next meeting and she will demonstrate the finished product. This project meets SHAC's goal for healthier youth. She will also present the project and provide flyers at the Presentation to Health Teachers at 2008 School Year Opening Meeting. She will update the group when the course goes on line. The Consultant will send announcement emails to each health teacher.


