
I received your letter that you received my fax regarding the books that are not appropriate to be in any school, that are in A.W. Dreyfoos School of the Arts.

Did you receive the materials that the Principal of Royal Palm High School told me to drop off, about the inappropriate books there also? I dropped it off about a week ago.

In answer to your letter: The Constitution never mentions the phrase "separation of church and state." That phrase was first used by Thomas Jefferson in a letter to the Danbury Baptist Association in 1802, 14 years after the Bill of Rights was written and sent to the state for approval. The phrase is also not to be found in the notes of the First Congress which drafted the Bill of Rights. The First Amendment does say: "Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof..."in fact, the Court has said, on numerous occasions, that separation is impossible. As Justice O'Connor held in speaking for the Supreme Court in Mergens, "If a State refused to let religious groups use the facilities open to others, then it would demonstrate not neutrality but hostility toward religion. Therefore, the Constitution does not demand that religion by kept out of our public schools. This comes from The American Center for Law and Justice. The Constitution also says freedom of speech.

The books that I mentioned that should be taken out of Dreyfoos, Royal Palm High and every other school in the world, these books are not teaching the kids anything but only poisoning their minds. Kids are in school to get an education and the books that I mentioned have nothing to do with teaching them an education, they are not in school to learn to be a homosexual or to learn to murder an innocent baby inside the mother's womb. Do the right thing and take this poison out of every school.

Thank you for your letter and continued support.




There was a review committee that met on January 12, 2007 regarding books that I wrote against having in Alexander W. Dreyfoos, Jr. School of the Arts. As a result of the written recommendation from the School Materials Review Committee to me, your request to remove the books you reviewed on the topics of abortion, atheism and homosexuality from the media center has been denied.

While both the Committee and I were disappointed that you were unable to accept our invitation to attend the meeting, the Materials Review Committee met Friday, January 12, 2007, reviewed your Citizen's Request for Reconsideration of Instructional Materials and analyzed all factors and criteria. Subsequently, your Citizens Request for Reconsideration of Instructional Materials was denied based on the following reasons:

- 1. Your comments on the Citizen's Request for Reconsideration of Instructional Materials are not sufficiently specific as the School Board procedures require: pages or parts of the books you found objectionable were not cited; the forms were photocopied for each topic (abortion, atheism, homosexuality) with book title and author information inserted at the top of each form; and on the reverse side of each form you added a general summary of the story line with comments related to your belief system.
- The Committee believes topics of abortion, atheism and homosexuality are social
  issues that high school students encounter in the media and in some situations
  within their families and social networks, such as in debate tournaments
  throughout the School District.
- The Florida Sunshine State Standards (LA.E.2.4.7) states that the student examines a literary selection from several critical perspectives; (SS.C.2) the student understands the role of the citizen in the American democracy and (SS.C.2.1) develops and defines his or her own political beliefs and tendencies.



 The Library Bill of Rights states that Libraries should provide materials and information presenting all points of view on current and historical issues. Materials should not be proscribed or removed because of partisan or doctrinal disapproval.

The School Materials Review Committee met on Friday, January 12, 2007 to discuss the Citizen's Request for Reconsideration of Instructional Materials submitted by parent of a Dreyfoos student. After reviewing her requests and analyzing all factors and criteria the Committee voted to dismiss request to remove the Media Center books she named on the topics of abortion, atheism and homosexuality for the reasons listed below:

- 1. The comments provides on the Citizens Request for Reconsideration of Instructional Materials are not sufficiently specific as the School Board procedures require. does not cite pages or parts of the books regarding her objections. The forms were photocopied for each topic (abortion, atheism, homosexuality) with book title and author information inserted at the top of each form. On the back, the provided add a general summary of the story line with comments related to her personal belief system.
- The Committee believes that the topics of abortion, atheism and homosexuality are current social issues that high school students encounter in the media and in some situations within their families and social networks. The topics are social issues that high school students encounter in debate tournaments throughout the School District.



- 3. The Florida Sunshine State Standards (LA.E.2.4.7) states that the student "examines a literary selection from several critical perspectives"; (SS.C.2) "the student understands the role of the citizen in the American democracy" and (SS.C.2.1) "develops and defines his or her own political beliefs and tendencies."
- 4. The Library Bill of Rights states that "Libraries should provide materials and information presenting all points of view on current and historical issues. Materials should not be proscribed or removed because of partisan or doctrinal disapproval."
