Dear Mrs. Lopez:

I am in receipt of your letters of concern dated January 31, 2007 and February 6, 2007, regarding school materials and religious implications at A. W. Dreyfoos School of the Arts and at Royal Palm Beach High School. Although it was unclear from your letter, upon further reflection I have decided to treat your letter as a request for an appeal to me of the decisions of the two principals as to this matter.


In compliance with Directive 8.122, through School Board Policy 8.12, each school convened a School Materials Review Committee to address your concerns. The two School Materials Review Committees met independently of one another but arrived at similar conclusions that support the continued student use of the school materials. I have reviewed the actions taken by each school and find that no further review is needed.

Directive 8.122 makes provision for you to appeal directly before the School Board if you so desire. If you want to appeal my decision, please notify the School Board in writing at the following address of your intent to appeal: Board Office, School Board of Palm Beach County, 3340 Forest Hill Boulevard, C-316, West Palm Beach, FL 33416. If you appeal, the District will schedule your appeal at an upcoming special meeting of the School Board for fifteen minutes, during which time you will be allowed to present your position.

If you decide to pursue this appeal, you will be notified of the time, date and place of the meeting.
