Specific Objectives:

During the duration of the component, participants will:

- 1. Demonstrate district, state, and federal policies and procedures related to identification and placement of exceptional students, specifically those in the speech-language impaired program.
- 2. Demonstrate appropriate procedures and documentation for pre-referral requirements including interventions, parent conferences, and observations.
- 3. Demonstrate appropriate screening, diagnostic instruments and procedures for exceptional students speech-language impaired.
- 4. Interpret and use diagnostic results for data-based program planning.

- 5. Implement current research-based intervention methods and strategies.
- 6. Demonstrate and use appropriate techniques and strategies with speech-language impaired students receiving services in a variety of service delivery models.
- 7. Recognize current research and other sources of information related to exceptional student education, specifically speech-language pathology and apply the information to participant's present role.
- 8. Become familiar with and use the District's Speech-Language Impaired Program Resource Manual.
- 9. Demonstrate and implement Medicaid billing procedures as governed by the district and state requirements.
- 10. Demonstrate and manage national certification requirements through information updated annually from the American Speech-Hearing-Language Association.
- 11. Demonstrate and manage state licensure requirements through information updated annually from the Florida Department of Health Medical Quality Assurance Department Board of Speech-Language Pathology and Audiology.
- 12. Implement bi-annual Medical Quality Assurance training required by the continuing education board of the Florida Department of Health Medical Quality Assurance Department Board of Speech-Language Pathology and Audiology.

DELIVERY PROCEDURES:

Participants will:

- 1. Participate in area and group activities, workshops, and conferences that will be offered throughout the year annually.
- 2. Review session handouts and available resources and references.
- 3. Receive technical assistance from qualified staff as needed to obtain mastery of information shared at workshops.

EVALUATION OF PARTICIPANTS:

Participants will:

- 1. Demonstrate 80% mastery on post-test.
- 2. Provide outcome products to be evaluated.

FOLLOW-UP ACTIVITES:

Participants will:

- 1. Complete compliance paperwork and send in for evaluation.
- 2. Comply with annual updates in policies and procedures as evidenced by review of placement paperwork.

COMPONENT EVALUATION:
