## Response to Land Inventory Divestment Question

The School Board asked staff to report back on the possibility of divesting any properties that the District may not need.

The following table shows the updated land inventory and the current and/or proposed use for each property. The table is set up in two sections: Land Banked School Sites and Miscellaneous Sites.

The Land Banked School Sites section lists the properties acquired through dedication, purchase and/or eminent domain that are earmarked for planned schools and future school needs.

The Miscellaneous section lists properties that are in inventory with no plans, this includes the "old" Cypress Hammock School in Canal Point that has been closed and boarded up. There are no plans for this site. Some of these miscellaneous properties may be candidates for divestiture; however, the potential revenue from the sale of these properties, if we could find buyers, would be relatively small. All of the possible sites for divestiture are located in the Glades where there is plenty of other land available.

The Lake Shore parcel is needed for water retention and the balance of the parcels have relatively deep muck, that are currently part of a school agricultural program, under lease and/or are part of the Trustees of the Internal Improvement Trust Fund (TIITF) which is to be used for public school purposes, and would revert back to TIITF if there were an attempt to use it for any other purpose.

The School District of Palm Beach County has been in a very active growth mode and has utilized its land inventory and acquisitions in a very effective manner leaving few unused properties in inventory.
