This letter is a request for your assistance to reinstate [REDACTED] into the Palm Beach County School System.


I believe [REDACTED] has reached a point in his life where he is making better choices.


In short, I believe that [REDACTED] has made the appropriate and necessary outcome decisions to place him back in Palm Beach County Schools.
