FINAL ORDER

THIS MATTER came to be heard by the School Board of Palm Beach County, Florida, ("School Board") for the purpose of entering a Final Order in the above-styled cause. In consideration of the Recommendation of the Superintendent and the attached exhibits, the School Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Respondent's parent was notified by the Principal of Boca Raton Community High School that the Respondent was being recommended for expulsion on November 1, 2004. The Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit A).
- 2. Respondent's parent was notified by the Superintendent of the School District of Palm Beach County, Florida ("School District") on January 12, 2005, via certified and regular mail, that the Respondent would be recommended to the School Board to be expelled from the School District. The Notice of Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit B).
- 3. Said notice advised Respondent's parent of their right to an administrative hearing to contest the charges contained therein provided they requested a hearing within ten (10) days of receipt of same.
- 4. An expulsion hearing was requested by the parent and an expulsion hearing was held on December 22, 2004. The recommended order, dated December 24, 2004, is incorporated by reference and made a part hereof as (Exhibit C).

CONCLUSIONS OF LAW

- 1. The School Board has jurisdiction over the subject matter and the parties hereto.
- 2. The School Board finds that the Respondent is guilty of the acts alleged by the Superintendent in the letter dated January 12, 2005, to wit:

Possession of marijuana with the intent to sell and/or distribute and possession of drug paraphemalia while on the campus of Boca Raton Community High School on October 28, 2004.

On October 28, 2004, was rendered a ten-day suspension, as documented by my letter to you (copy attached). Pursuant to Florida Statute § 230.23(6)©, which authorizes the School Board to decide cases recommended for expulsion. I have, in accordance with our District's discipline matrix recommended to the Expulsion Screening Committee that the School Board expel from the School District of Palm Beach County.

My recommendation is based on substantial evidence available to me supporting the following serious misconduct (Police Case Number 04-3316): Officer Vizy of the school police reported that the drug-sniffing dog alerted to a car that was later identified as a car. Officer Vizy, Officer Golden (School police officer assigned to Boca High), and Mr. O'Leath (Boca High Dean) escorted to his car. A search of the car led to the discovery of two bags of marijuana, empty plastic bags, a scale, and a pipe. The weight of the marijuana exceeded 20 grams.

Pursuant to Florida Statute § 230.33(8), the Superintendent may extend the ten-day suspension until the date of the School Board Meeting when the School Board will act on this expulsion recommendation. If you choose to have enrolled in the School District of Palm Beach County, he will be assigned to the Department of Alternative Education when his suspension ends.

RECOMMENDED ORDER

A Final Hearing was held in this matter in Boca Raton, Florida on December 22, 2004. The issue is whether to expel who is a student and is presently enrolled in the Boca Raton Community High School, from the Palm Beach County School System pursuant to the provisions of Sections, 120.57(2), 228.041(26), 230.03, 230.23(6)(c)(1), 232.25, 232.26, Florida Statutes, as well as with regard to Palm Beach County School Board Policies 5.18 and 5.1813.

FINDINGS OF FACT

- 1. Raton Community High School located in Boca Raton, Palm Beach County, Florida.
- 2. It is alleged that on October 28, 2004, was in possession of marijuana with the intent to distribute and in possession of drug paraphernalia while on the campus of his High School. If the allegations are true, then the student committed an act in violation of School Board Policies 5.18 and 5.1813, which subjects a student to disciplinary action, including expulsion.

The mother of the student was notified of the allegations and requested a hearing. At the time of the hearing, the student and his mother were present.



The School Board called one witness and introduced 1 document into evidence. The student testified in his own behalf. Set forth below is a synopsis of the testimony given by the witnesses.

P/O KENNETH VIZY. The officer and his K-9 partner were checking cars in the parking lot of the school when the dog alerted the officer of narcotics in an El Camino auto. While attempting to ascertain the owner, the student approached the car. When the officer attempted to question the student, he became uncooperative and would not identify himself. When the officer asked the student to come to the office, he resisted and was placed in handcuffs and brought to the office. P/O Golden and Assistant Principal Robert O'Leath were summoned and the student was read his Miranda rights. He signed the Miranda warning and a consent form to search his car. He told the officer that he had a pipe in his car. When the officer and the student got to the car, the student told the officer how to remove a portion of the dashboard which revealed a pipe that appeared to contain marijuana residue. In the glove compartment there were two bags of suspected marijuana weighing 28.10 grams and a small digital scale. A field test was conducted which indicated positive for marijuana. The student told the officer that he could have sold the marijuana for \$1200.00.

Robert O'Leath was not called as a witness but it was stipulated that his testimony would be the same as P/O Vizy.

The student testified in his own behalf. They would not let me call my lawyer or my mother. I told them not to search my car. They would not let me see the student handbook. The officer lied to me about searching my car. I never said \$1200.00; I said \$300.00 is a more reasonable amount. I did not intend to sell the marijuana and when I bout the two bags, the scale came with it.

The witness for the School Board was credible and his credibility was not impeached. His demeanor was consistent with his sincere effort to relate the facts to the best of his ability without trying to enhance or exaggerate his testimony.

In reviewing the testimony, I find that the Palm Beach County School Board did prove by a preponderance of the believable evidence that the respondent, while on the school campus of Boca Raton Community High School, did possess with the intent to sell/distribute a controlled substance (marijuana) and that he did have in his possession drug paraphernalia.

CONCLUSIONS OF LAW

Every student of Palm Beach County has a right and obligation to attend a public school. Expulsion is the removal of these rights and obligations. These rights and obligations can be revoked under conditions set by the School Board. Florida Statutes Section 228.041(26).

The principal of a school or his designated representative, may recommend to the Superintendent of a school system the expulsion of any student who has committed a serious breach of conduct, including but not limited to possession of and or selling/distributing a controlled substance (marijuana) on a school campus or any other act which substantially disrupts the orderly conduct of the school. Florida Statutes Section 232.26(1)©.

The Superintendent may then recommend expulsion to the School Board setting forth the charges against the pupil and advising the pupil and his parent or guardian of his right to due process as prescribed by Florid Statute 120.57(2), and Florida Statute Section 230.33(8)©.

Palm Beach County School Board Policy 5.1813, incident code 74 requires mandatory recommendation for expulsion.

RECOMMENDATION

Based on the foregoing findings of fact and conclusions of law, the undersigned Hearing Officer recommends that the respondent, be expelled from the Palm Beach County School System. The Hearing Office finds that the evidence supports a conclusion that the Respondent was in possession of a controlled substance (marijuana) with the intent to sell/distribute and that he was in possession of drug paraphernalia. These are serious deeds of misconduct and have the potential for serious bodily harm to the respondent, to other students and to members of the staff. These charges are substantial.

They were proven by a preponderance of the evidence. There is only one rational conclusion and that is a recommendation of expulsion.

ON OCTOBER 28, 2004, ON APPROXIMATELY 1047 HOURS, WHILE AT BOCA RATON HIGH SCHOOL (1501 N.W. 15TH COURT, BOCA RATON, FL), WHILE CONDUCTING A SEARCH OF THE TEACHERS' PARKING LOT, SCHOOL DISTRICT OF PALM BEACH COUNTY NARCOTIC DETECTION K-9 "BOSCO" GAVE AN ABNORMAL RESPONSE TO THE PASSENGER SIDE DOOR OF A 1984 CHEVY "EL CAMINO" SILVER-IN-COLOR (LICENSE FL). WHILE IN THE AREA, I ASKED A STUDENT (LATER NUMBER IDENTIFIED AS WHO WAS WALKING IN THE AREA, WHERE HE WAS GOING; HE ADVISED THAT HE WAS GOING TO HIS CAR. HE IDENTIFIED HIS VEHICLE AS AN "EL CAMINO". I ASKED HIM HIS NAME; HE REFUSED TO IDENTIFY HIMSELF. I THEN ASKED HIM TO REPORT WITH ME TO THE OFFICE. I EXPLAINED THAT HE NEEDED TO IDENTIFY HIMSELF. HE GAVE THE NAME AND DID NOT ADVISE FURTHER (MUMBLING AND SHAKING HIS HEAD). I INSTRUCTED HIM TO STAY SEATED IN THE FRONT OFFICE; THAT IF HE CONTINUED NOT TO FOLLOW MY DIRECTIONS HE WOULD BE PLACED IN HANDCUFFS AND NOT TO MOVE. HE THEN BEGAN TO OPERATE HIS CELLPHONE. I ADVISED HIM NOT TO. HE CONTINUED AND AS I BEGAN TO ATTEMPT TO TAKE THE PHONE (TO STOP THE OPERATION) HE BECAME RESISTIVE, PULLING AWAY FROM MY PERSON. HE WAS ADVISED THAT HE WAS BEING PLACED IN HANDCUFFS. HE CONTINUED TO STRUGGLE, ATTEMPTING TO BREAK HOLD OF ME. AT ONE POINT HE WAS STANDING ON THE BENCH HE WAS SITING ON AND I WAS THEN ABLE TO PLACE HIM IN HANDCUFFS.

DURING THE INVESTIGATION, WAS ADVISED OF HIS CONSTITUTIONAL RIGHTS AFTER WHICH HE A FIRST REFUSED TO COOPERATE (ADVISING THAT HE WANTED HIS ATTORNEY).
