FINAL ORDER

THIS MATTER came to be heard by the School Board of Palm Beach County, Florida, ("School Board") for the purpose of entering a Final Order in the above-styled cause. In consideration of the Recommendation of the Superintendent and the attached exhibits, the School Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Respondent's parent was notified by the Principal of Bear Lakes Middle School that the Respondent was being recommended for expulsion on November 16, 2004. The Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit A).
- Respondent's parent was notified by the Superintendent of the School District of Palm Beach County, Florida ("School District") on January 12, 2005, via certified and regular mail, that the Respondent would be recommended to the School Board to be expelled from the School District. The Notice of Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit B).
- 3. Said notice advised Respondent's parent of their right to an administrative hearing to contest the charges contained therein provided they requested a hearing within ten (10) days of receipt of same.
- 4. No hearing request has been received in the Office of the Chief Academic Officer.

CONCLUSIONS OF LAW

- 1. The School Board has jurisdiction over the subject matter and the parties hereto.
- 2. The School Board finds that the Respondent is guilty of the acts alleged by the Superintendent in the letter dated January 12, 2005, to wit:

Possession of drugs with the intent to sell and/or distribute while on the campus of Bear Lakes Middle School on November 16, 2004.

ORDERED AND ADJUDGED by the School Board in regular session that the recommendation of the Superintendent be accepted and confirmed. Except in cases of indigence, the Court will require a filing fee and payment for preparing the record on appeal. For further explanation of the right to appeal, refer to § 120.68, Fla. Stat., and the Florida Rules of Appellate Procedure.

Ms. Smith turned over the items to me and I advised I that she was being placed under arrest for the offense of Possession of Marijuana with Intent to Sell Within 1000 feet of School Grounds. also advised her of her Miranda Rights, which she acknowledged mother and Ms. Esther Muniz, Guidance understanding. Counselor were present.

I tested the suspected marijuana with a NARK #8 Duquenois Reagent Test kit with produced a positive result for marijuana. The total weight of the marijuana is approximately 22 grams. I placed the marijuana into evidence. I also placed the currency into evidence as suspected proceeds from the sale of marijuana.

Lt. William Lammie took possession of the evidence and transported to the JAC.

Due to the amount of marijuana being in excess of personal consumption and that the Defendant, offered no explanation for possessing such a large amount of cash (\$503.00), Probable Cause exists for the charge of Possession of Marijuana to Sell within 1000 feet of school grounds.




