FINAL ORDER

**THIS MATTER** came to be heard by the School Board of Palm Beach County, Florida, ("School Board") for the purpose of entering a Final Order in the above-styled cause. In consideration of the Recommendation of the Superintendent and the attached exhibits, the School Board makes the following Findings of Fact and Conclusions of Law.


FINDINGS OF FACT

1. Respondent's parent was notified by the Principal of Glades Central Community High School that the Respondent was being recommended for expulsion on November 30, 2004. The Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit A).
2. Respondent's parent was notified by the Superintendent of the School District of Palm Beach County, Florida ("School District") on January 12, 2005, via certified and regular mail, that the Respondent would be recommended to the School Board to be expelled from the School District. The Notice of Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit B).
3. Said notice advised Respondent's parent of their right to an administrative hearing to contest the charges contained therein provided they requested a hearing within ten (10) days of receipt of same.
4. No hearing request has been received in the Office of the Chief Academic Officer.

CONCLUSIONS OF LAW

1. The School Board has jurisdiction over the subject matter and the parties hereto.
2. The School Board finds that the Respondent is guilty of the acts alleged by the Superintendent in the letter dated January 12, 2005, to wit:

Committed battery on a School Board Employee and a threat of violence (high level) while on the campus of Glades Central Community High School on November 23, 2004.

**ORDERED AND ADJUDGED** by the School Board in regular session that the recommendation of the Superintendent be accepted and confirmed.  is hereby expelled from the School District for one calendar year from December 10, 2004. Your daughter may choose to continue educational services during

his expulsion period at the ACS site. However, if your daughter is dismissed from that program by ACS, no further educational services will be offered by the District until the expulsion period is ended.

This Order may be appealed within thirty (30) days by filing a notice of appeal with the District Court of Appeal. Except in cases of indigence, the Court will require a filing fee and payment for preparing the record on appeal. For further explanation of the right to appeal, refer to § 120.68, Fla. Stat., and the Florida Rules of Appellate Procedure.

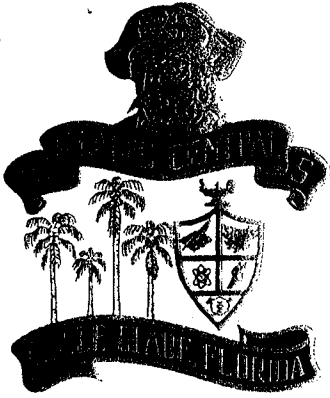

On November 23, 2004 your daughter, [REDACTED], was rendered a ten (10) day suspension as documented by my letter to you, a copy of which is attached.

Pursuant to Florida Statute §230.23(6)(c) which authorizes the School Board to decide cases recommended for expulsion, I have this date recommended to the Expulsion Screening Committee that the School Board expel [REDACTED] from the public schools of Palm Beach County. My recommendation is based on substantial evidence available to me supporting the following serious misconduct:

Student punched Assistant Principal in the face and threatened to kill him.  
School Police Case No. 3741.

Pursuant to Florida Statute §230.33(8), the Superintendent may extend the ten (10) day suspension until the date of the School Board meeting at which time the School Board will act on the expulsion. As of December 10, 2004, [REDACTED] is assigned to the Department of Alternative Education.

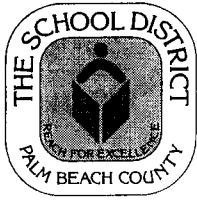

**NOTICE OF RECOMMENDATION FOR EXPULSION**

Based upon the recommendation of Dr. Edward Harris, Principal of Glades Central Community High School, and in accordance with **Florida Statute § 1006.07**, and Palm Beach County **School Board Policy 5.1813**, I will request that the School Board of Palm Beach County, Florida, expel your daughter, [REDACTED] from the Palm Beach County School District. This decision is based upon the following action:

Committed battery on a School Board Employee and a threat of violence (high level) while on the campus of Glades Central Community High School on November 23, 2004.

Pursuant to **Florida Statute § 120.569**, you have the right to an administrative hearing. Your request must be received by the Office of the Chief Academic Officer within ten (10) days of the date of this letter. If you request a hearing, a hearing officer will be appointed pursuant to **Florida Statute § 120.81(1)(e)**. If you do not request a hearing, this recommendation will become final.

Your daughter may receive educational services at the ACS Transition Program during this expulsion due process. If you have any questions regarding the expulsion due process or the educational services available at the ACS Intensive Site, please contact the Office of the Chief Academic Officer at 561-649-6888.


On November 23, 2004, at approximately 10:40 a.m., I was in the cafeteria with the in-school suspension students, Ms. Cathey Jackson and other staff members. Dr. Rivera, Mr. Tim Abrams and Coach Wiley, Athletic Director, came to talk with [REDACTED] who was in the in-school suspension program and eating lunch.

They took [REDACTED] out of the cafeteria to talk with her. As they re-entered the cafeteria, I heard [REDACTED] shouting and talking very loud to Mr. Abrams saying, "that you want to do that anyway." [REDACTED] began shouting louder and walking to Mr. Abrams and pointing her finger and hand directly in Mr. Abrams' face. He asked [REDACTED] twice to remove her finger and hand from his face. The third time, her finger touched Mr. Abrams' face and he removed her finger and hand. [REDACTED] punched Mr. Abrams in the face with her fist. Mr. Abrams restrained her by both wrists and took her down to the table and held her until Coach Wiley came to assist.

[REDACTED] stated to Mr. Abrams, "I am going to kill you wherever I see you."

We called for School Police Officer Ron Williams. [REDACTED] stated two or three times in front of Officer Williams that she was going to kill Mr. Abrams.

On the above date at approximately 10:58 hours while employed as a police officer with the School District of Palm Beach County, Florida assigned to Glades Central Community High School located at 1001 Southwest Avenue M, Belle Glade, Florida, I was requested to report to the school's cafeteria by Assistant Principal, Dr. Rivera. Upon reporting to the cafeteria, I saw several adult male staff members in the southwest area. I then saw the victim, Mr. Timothy J. Abrams (Assist. Principal) who pointed to the southwest corner where another male staff member, Mr. Gabriel Wiley d. o. b. [REDACTED] was blocking the path of the arrestee, b/f [REDACTED] (d. o. b. [REDACTED]). When asked what was the problem, the victim advised me that he was requesting criminal charges against the arrestee for punching him about the face area. According to the victim he stated that he along with Assistant Principal Dr. J. Rivera and the Athletic Director, Mr. Gabriel Wiley went to speak with the arrestee (who was assigned to In School Suspension for inappropriate behavior), and attempted to explain to her that she would not be able to play in or attend the girl's basketball game at Suncoast High School. The victim, Dr. Rivera and Mr. Willey all stated that the arrestee became unruly and began to point her fingers and hand in the victim's face. The victim said that he asked the arrestee several times to discontinue her pointing in his face, and according to the victim the arrestee pointed again and touched his face area as she pointed, therefore prompting him to restrain her in fear that she would actually hit him. The victim said that as he was restraining the arrestee, the arrestee swung and punched him about the face.

At that point I informed the arrestee that she was under arrest for battery on a school board employee and immediately advised her of her Miranda Warnings verbally. The arrestee was placed in department issued hand cuffs (double locked) and escorted to the office of the school police on campus where she was processed and later turned over to her mother, [REDACTED].

When escorting the arrestee to the school police's office on campus she made several threats towards the victim. I personally heard the arrestee tell the victim that when she sees him on the streets he was going to die and that she was going to get him when she gets a chance. I advised the arrestee to be quite and not continue making the threatening comments, but she continued.

The arrestee [REDACTED] was arrested and charged with the following charges: Battery on a School Board Employee 784.081 F. S. S. and Corruption by Threat Against a Public Official 838.021 F. S. S.
