FINAL ORDER

THIS MATTER came to be heard by the School Board of Palm Beach County, Florida, ("School Board") for the purpose of entering a Final Order in the above-styled cause. In consideration of the Recommendation of the Superintendent and the attached exhibits, the School Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Respondent's parent was notified by the Director of Alternative Education's Designee that the Respondent was being recommended for expulsion on January 14, 2005. The Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit A).
- 2. Respondent's parent was notified by the Superintendent of the School District of Palm Beach County, Florida ("School District") on February 7, 2005, via certified and regular mail, that the Respondent would be recommended to the School Board to be expelled from the School District. The Notice of Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit B).
- 3. Said notice advised Respondent's parent of their right to an administrative hearing to contest the charges contained therein provided they requested a hearing within ten (10) days of receipt of same.
- 4. No hearing request has been received in the Office of the Chief Academic Officer.

CONCLUSIONS OF LAW

- 1. The School Board has jurisdiction over the subject matter and the parties hereto.
- 2. The School Board finds that the Respondent is guilty of the acts alleged by the Superintendent in the letter dated February 7, 2005, to wit:

Committed high-level threat of violence while on the campus of North Intensive on January 11, 2005.

ORDERED AND ADJUDGED by the School Board in regular session that the recommendation of the Superintendent be accepted and confirmed. The superintendent be accepted and confirmed. is no longer eligible to receive educational services during his expulsion period and no further educational services will be offered by the District until the expulsion period is ended.

This Order may be appealed within thirty (30) days by filing a notice of appeal with the District Court of Appeal. Except in cases of indigence, the Court will require a filing fee and payment for preparing the record on appeal. For further explanation of the right to appeal, refer to § 120.68, Fla. Stat., and the Florida Rules of Appellate Procedure.

On 01/11/2005 your son/daughter/ward was rendered a ten (10) day suspension as documented by my letter to you, a copy of which is attached.

Pursuant to Florida Statute § 230.23(6)(c), which authorizes the School Board to decide cases recommended for expulsion, I have this date recommended to the Expulsion Screening Committee that the School Board expel your son/daughter/ward from the public schools of Palm Beach County. My recommendation is based on substantial evidence available to me supporting the following serious misconduct.

Threat of Violence - High Level

Stated to Mr. Gervin "I'll go get my brothers. Better watch out for your truck. I'm gonna shoot you."



Thompson, Director of Alternative Education, and in accordance with Florida Statute § 1006.07, and Palm Beach County School Board Policy 5.1813, I will request that the School Board of Palm Beach County, Florida, expel your son, from the Palm Beach County School District. This decision is based upon the following action:

Pursuant to Florida Statute § 120.569, you have the right to an administrative hearing. Your request must be received by the Office of the Chief Academic Officer within ten (10) days of the date of this letter. If you request a hearing, a hearing officer will be appointed pursuant to Florida Statute § 120.81(1)(e). If you do not request a hearing, this recommendation will become final.

Your son may receive educational services at the ACS Transition Program during this expulsion due process. However, due to the seriousness of this incident, if the Board votes to expel him, your son will not be eligible to continue attending the ACS Transition Program during the remaining expulsion period. If you have any questions regarding the expulsion due process or the educational services available at the ACS Intensive Site, please contact the Office of the Chief Academic Officer at 561-649-6888.

Narrative

On this date at about 1105 hrs, I met with b/m Grier, Lateef, the complainant, in reference to an unruly student who ran away from the Excel Alternative School. I also met with b/m Gervin, Eric

T, the principal in reference to this. Both the complainant and principal expressed concern that a b/m student, identified as the principal polymer had been very violently angry over a minor incident, had threatened the employees with bodily harm, torn off his own shirt and fled on foot. A short time after this, Off Montoya and myself found the student hiding behind an abandoned building at 3860 S Old Dixie Hwy. The student's emotion ran the spectrum from calm and cooperative to tearful angry and obscene. I transported the student back to Excel school where it was determined that due to the rapid and unpredictable mood swings, threats and violent threats, the student was a danger to himself and others. For these reasons, the 15 yoa student was transported to Columbia Hospital for evaluation under the Baker Act. Nothing further.
