**FINAL ORDER**

**THIS MATTER** came to be heard by the School Board of Palm Beach County, Florida, ("School Board") for the purpose of entering a Final Order in the above-styled cause. In consideration of the Recommendation of the Superintendent and the attached exhibits, the School Board makes the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Respondent's parents were notified by the Principal of John F. Kennedy Middle Magnet School that the Respondent was being recommended for expulsion on September 28, 2005. The Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit A).
2. Respondent's parents were notified by the Superintendent of the School District of Palm Beach County, Florida ("School District") on September 30, 2005, via certified and regular mail, that the Respondent would be recommended to the School Board to be expelled from the School District. The Notice of Recommendation for Expulsion is incorporated by reference and made a part hereof as (Exhibit B).
3. Said notice advised Respondent's parents of their right to an administrative hearing to contest the charges contained therein provided they requested a hearing within ten (10) days of receipt of same.
4. No hearing request has been received in the Office of the Chief Academic Officer.

**CONCLUSIONS OF LAW**

1. The School Board has jurisdiction over the subject matter and the parties hereto.
2. The School Board finds that the Respondent is guilty of the acts alleged by the Superintendent in the letter dated September 13, 2005, to wit:

Possession of other potentially dangerous items and fighting while on the campus of John F. Kennedy Middle Magnet School on September 26, 2005.

**ORDERED AND ADJUDGED** by the School Board in regular session that the recommendation of the Superintendent be accepted and confirmed. [REDACTED] is hereby expelled from the School District for one calendar year from October 11, 2005. The Respondent may choose to continue educational services during her

expulsion period at the ACS site. However, if the Respondent is dismissed from that program by ACS, no further educational services will be offered by the District until the expulsion period is ended.

This Order may be appealed within thirty (30) days by filing a notice of appeal with the District Court of Appeal. Except in cases of indigence, the Court will require a filing fee and payment for preparing the record on appeal. For further explanation of the right to appeal, refer to § 120.68, Fla. Stat., and the Florida Rules of Appellate Procedure.

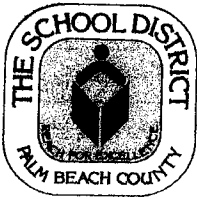



This decision is based upon the following action:

Possession of other potentially dangerous items and fighting while on the campus of John F. Kennedy Middle Magnet School on September 26, 2005.

Pursuant to Florida Statute § 120.569, you have the right to an administrative hearing. Your request must be received by the Office of the Chief Academic Officer within ten (10) days of the date of this letter. If you request a hearing, a hearing officer will be appointed pursuant to Florida Statute § 120.81(1)(e). If you do not request a hearing, this recommendation will become final.

Your daughter may receive educational services at the ACS Transition Program during this expulsion due process. If you have any questions regarding the expulsion due process or the educational services available at the ACS Intensive Site, please contact the Office of the Chief Academic Officer at 561-649-6888.

NARRATIVE CONTINUATION

On 09-26-05 at 0725 hours, while on patrol at John F Kennedy Middle School (JFKMS), 1901 Avenue S, Riviera Beach, FL, I received a report from School District of Palm Beach County (SDPBC) Dispatch. Dispatch reported the following: The SDPBC Transportation Department received a call at approximately 0640 hours from School Bus #0208 (see Vehicle Report) Driver Natasha Rodgers (DOB: 01-08-75). She called to report a stabbing that occurred on her bus near the intersection of 38th Street and Broadway, West Palm Beach, FL. SDPBC Transportation Department, after receiving the call from Rodgers, called the West Palm Beach Police Department (WPBPD) (WPBPD Dispatch received the call from SDPBC Transportation Department at 0645 hours) to notify that department of the stabbing (see WPBPD Incident / CAD # 5-127126). WPBPD, in turn, dispatched a WPBPD patrol unit to meet with Rodgers and her bus. SDPBC Dispatch told me that a Police Officer from WPBPD and Bus # 0208 would meet me in the JFKMS Bus Loop.


On arriving at the JFKMS bus loop, I met with WPBPD Officers Mary Elizabeth Hooper and Brian Mahoney. Hooper and Mahoney told me they received a call, via their police radio, from WPBPD Dispatch to respond to a stabbing that occurred on a PBCSD school bus at 38th Street and Broadway, West Palm Beach, FL. Upon meeting the bus, Officer Hooper met with and transported JFKMS student and suspect [REDACTED] (DOB: [REDACTED]) to JFKMS. Officer Mahoney transported JFKMS student and victim [REDACTED] (DOB: [REDACTED]) to JFKMS. Officer Mahoney turned over a pair of scissors to me (see Property Report). Officers Hooper and Mahoney dropped [REDACTED] and [REDACTED] off at the JFKMS bus loop.

I met with suspect [REDACTED]. Post Miranda, she told me the following: She and [REDACTED] argued the Friday (09-23-05) prior to today. On Friday (09-23-05) he threatened to fight her.

On 09-26-05, while waiting for the bus, she pulled a pair of scissors that she obtained over the weekend from a relative, out of her backpack. Prior to entering the school bus, she placed the scissors in her pocket where she could easily access them. Prior to the bus arriving, [REDACTED] threatened to fight her and she said if you "want to fight then do it". The bus arrived and, as she was attempting to enter the bus, [REDACTED] began pushing her into the doorway of the bus. She became upset and called him "gay" as he was pushing her into the bus. The verbal arguing continued as they took their seats on the bus. [REDACTED] then stood up and went over to her and struck her with his fist, in the face. She began punching back. She then pulled out the pair of scissors from her pocket. Just as she was attempting to stab [REDACTED], JFKMS student [REDACTED] (DOB: [REDACTED]) stepped in to try to break up the fight and this is when she stabbed [REDACTED] in the left biceps. She did not intend to stab [REDACTED]. [REDACTED] then walked toward the front of the bus in an attempt to escape being stabbed again. She then began to stab [REDACTED]. She stabbed [REDACTED] on the top of the head and on the right cheek. She also slashed the right side of his neck just above the jugular. In the process of stabbing and slashing [REDACTED], the handle of the scissors broke and she sustained a minor cut to her right hand from the broken scissors handle. She, [REDACTED], and [REDACTED] were treated on scene (38th Street and Broadway, West Palm Beach, FL) by EMS and on arrival at JFKMS.

I met with JFKMS student, victim and Bus # 0208 passenger [REDACTED] and he told me the following: [REDACTED] was calling him "gay" at the bus stop, prior to getting on the bus to go to JFKMS. He did not like being called "gay". He intended on fighting her at the bus stop prior to getting on the bus, but the bus was just pulling up. [REDACTED] continued calling him "gay" on the bus. He could not physically contain his anger any longer and this is when he stood up, leaned over [REDACTED] and struck her in the face with his fist. [REDACTED] then pulled out a pair of scissors stabbed him on the top of the head and on the right cheek. She also slashed the right side of his neck on the area just above the jugular. He then said he grabbed the scissors and stabbed her in the hand.

According to [REDACTED] and witnesses, [REDACTED] never stabbed [REDACTED].

I met with JFKMS student, victim and Bus # 0208 passenger [REDACTED] and he told me the following: He was waiting at the bus stop for the bus that takes him to school. While waiting, he saw [REDACTED] and [REDACTED] verbally arguing. The bus arrived and he, [REDACTED] and [REDACTED] entered the bus. [REDACTED] and [REDACTED] continued arguing on the bus. [REDACTED] continued to argue and then he jumped up and went over to [REDACTED] and started to hit her. He got up out of his seat and went over to [REDACTED] to pull him away from [REDACTED] in an effort to stop the fight. In the process of pulling [REDACTED] away he spun [REDACTED] around and this is when he was stabbed with a pair of scissors in the left biceps by [REDACTED]

I met with Bus Driver Natasha Rogers and she told me the following: She heard students fighting at the back of the bus and attempted to calm them down. She contacted SDPBC Transportation Department when [REDACTED] came to the front of the bus and showed her the stab wound to his arm. She then told [REDACTED] to come to the front of the bus. She then waited for Law Enforcement to arrive.

I met with JFKMS student and Bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and she told me the following: She saw [REDACTED] and [REDACTED] arguing at the bus stop on her arrival. They continued to argue on the bus. [REDACTED] got up and hit [REDACTED] and they started to fight. [REDACTED] then pulled out a pair of scissors and cut [REDACTED].

I met with JFKMS student and bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and he told me the following: He was waiting at the bus stop for his bus. He heard from other students waiting at the bus stop that [REDACTED] and [REDACTED] wanted to fight. [REDACTED] took off her backpack to fight, but the bus pulled up and this is when [REDACTED] and [REDACTED] entered the bus. Once on the bus [REDACTED] and [REDACTED] began to verbally argue and physically fight.

I met with JFKMS student and bus #0208 passenger [REDACTED] (DOB: [REDACTED]) and he told me the following: On the way to and on arrival at the bus stop, he heard [REDACTED] and [REDACTED] verbally arguing. [REDACTED] called [REDACTED] "gay". While on the bus, [REDACTED] struck [REDACTED] in the face and they both began to fight. [REDACTED] then pulled out a pair of scissors and began to swing wildly in [REDACTED]'s direction. [REDACTED] then threw his shoe at [REDACTED]. In turn, [REDACTED] threw one of her shoes at him. [REDACTED] then ran up to brake up the fight.

I met with JFKMS student and Bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and he told me the following: He heard students yelling at the back of the bus about something that happened at the bus stop. Then, he saw [REDACTED] and [REDACTED] get up from their seats and start fighting. While they were fighting, [REDACTED] pulled out a pair of scissors and began stabbing [REDACTED]. [REDACTED] went to the back of the bus to brake up the fight and this is when he saw [REDACTED] be stabbed by [REDACTED].

I met with JFKMS student and Bus # 0208 Passenger [REDACTED] (DOB: [REDACTED]) and he told me the following: [REDACTED] and [REDACTED] started fighting on the bus. [REDACTED] struck her with his fist in the stomach and [REDACTED] struck [REDACTED] in the head with her fist. [REDACTED] tried to brake the fight up. He then saw [REDACTED] run to the front of the bus. [REDACTED] picked up her shoe in an attempt to hit [REDACTED].

I met with JFKMS student and Bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and she told me [REDACTED] and [REDACTED] started fighting on the bus. [REDACTED] attempted to brake up the fight and that is when she saw [REDACTED] stab [REDACTED].

I met with JFKMS student and Bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and she told me the following: [REDACTED] and [REDACTED] started arguing on the bus. [REDACTED] and [REDACTED] stood up at started fighting, but she did not see who threw the first punch. [REDACTED] and her brother, [REDACTED], attempted to stop the fight and this is when [REDACTED] bent down and retrieved a pair of scissors. [REDACTED] with scissors in hand, attempted to stab [REDACTED] but stabbed [REDACTED] in the arm instead.

I met with JFKMS student and Bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and she told me the following: Students at the bus stop were talking about [REDACTED] and [REDACTED] fighting. [REDACTED] asked her to hold her backpack and this is when [REDACTED] took the scissors out of her backpack. While on the bus [REDACTED] and [REDACTED] started fighting. Shortly after the fight began, [REDACTED], [REDACTED], and [REDACTED] broke up the fight.

I met with JFKMS student and Bus #0208 passenger [REDACTED] (DOB: [REDACTED]), [REDACTED]'s brother, and he told me the following: [REDACTED] and [REDACTED] were fighting on the bus. [REDACTED] pulled out a pair of scissors and tried to stab [REDACTED]. He noticed the palm of [REDACTED]'s right hand, the hand in which she wielded the scissors, was red.

I met with JFKMS student and Bus # 0208 passenger [REDACTED]. He saw [REDACTED] and [REDACTED] verbally arguing on the bus.

[REDACTED] did use a deadly weapon, a pair of scissors, in the course of Intentionally or knowingly causing great bodily harm to [REDACTED] and [REDACTED] in violation of FS.S 784.045 and did possess a weapon, a pair of scissors, on school property, a school bus, in violation of FS.S 790.115.

While processing / interviewing [REDACTED], I placed her in handcuffs. I checked the cuffs for proper fit and insured the cuffs were double locked. I contacted [REDACTED]'s legal guardian, [REDACTED], and informed her of the above incident. School District of Palm Beach County Police Lieutenant M Baxter transported [REDACTED] to her house. [REDACTED] was administratively disciplined.

I also contacted [REDACTED]'s mother, [REDACTED] and [REDACTED]'s mother, [REDACTED], and informed them of the above incident. [REDACTED] and [REDACTED] wish to pursue charges in this case. [REDACTED] was administratively disciplined for his role in the fight on the bus. [REDACTED] was not administratively disciplined.

I am unable at this time to give [REDACTED] or [REDACTED] a Victim Rights Packet at this time as they left before I could give them a packet. I will mail each of them a Victim Rights Packet.

WPBPD, in turn, dispatched a WPBPD patrol unit to meet with Rodgers and her bus. SDPBC Dispatch told me that a Police Officer from WPBPD and Bus # 0208 would meet me in the JFKMS Bus Loop.

On arriving at the JFKMS bus loop, I met with WPBPD Officers Mary Elizabeth Hooper and Brian Mahoney. Hooper and Mahoney told me they received a call, via their police radio, from WPBPD Dispatch to respond to a stabbing that occurred on a PBCSD school bus at 38th Street and Broadway, West Palm Beach, FL. Upon meeting the bus, Officer Hooper met with and transported JFKMS student and suspect [REDACTED] (DOB: [REDACTED]) to JFKMS. Officer Mahoney transported JFKMS student and victim [REDACTED] (DOB: [REDACTED]) to JFKMS. Officer Mahoney turned over a pair of scissors to me (see Property Report). Officers Hooper and Mahoney dropped [REDACTED] and [REDACTED] off at the JFKMS bus loop.

NARRATIVE CONTINUATION

I met with suspect [REDACTED]. Post Miranda, she told me the following: She and [REDACTED] argued the Friday (09-23-05) prior to today. On Friday (09-23-05) he threatened to fight her.

On 09-26-05, while waiting for the bus, she pulled a pair scissors that she obtained over the weekend from a relative out of her backpack. Prior to entering the school bus, she placed the scissors in her pocket where she could easily access them. Prior to the bus arriving, [REDACTED] threatened to fight her and she said if you "want to fight then do it". The bus arrived and, as she was attempting to enter the bus, [REDACTED] began pushing her into the doorway of the bus. She became upset and called him "gay" as he was pushing her into the bus. The verbal arguing continued as they took their seats on the bus. [REDACTED] then stood up and went over to her and struck her in the face with his fist. She began punching back. She then pulled out the pair of scissors from her pocket. Just as she was attempting to stab [REDACTED] JFKMS student [REDACTED] (DOB: [REDACTED]) stepped in to try to break up the fight and this is when she stabbed [REDACTED] in the left biceps. She did not intend to stab [REDACTED]. [REDACTED] then walked toward the front of the bus in an attempt to escape being stabbed again. She then began to stab [REDACTED]. She stabbed [REDACTED] on the top of the head and on the right cheek. She also slashed the right side of his neck just above the jugular. In the process of stabbing and slashing [REDACTED], the handle of the scissors broke and she sustained a minor cut to her right hand from the broken scissors handle. She, [REDACTED], and [REDACTED] were treated on scene (38th Street and Broadway, West Palm Beach, FL) by EMS and on arrival at JFKMS.

I met with JFKMS student, victim and Bus # 0208 passenger [REDACTED] and he told me the following: [REDACTED] was calling him "gay" at the bus stop, prior to getting on the bus to go to JFKMS. He did not like being called "gay". He intended on fighting her at the bus stop prior to getting on the bus, but the bus was just pulling up. [REDACTED] continued calling him "gay" on the bus. He could not physically contain his anger any longer and this is when he stood up, leaned over [REDACTED], and struck her in the face with his fist. [REDACTED] then pulled out a pair of scissors stabbed him on the top of the head and on the right cheek. She also slashed the right side of his neck on the area just above the jugular. He then said he grabbed the scissors and stabbed her in the hand.

Note: According to [REDACTED] and witnesses, [REDACTED] never stabbed [REDACTED]

I met with JFKMS student, victim and Bus # 0208 passenger [REDACTED] and he told me the following: He was waiting at the bus stop for the bus that takes him to school. While waiting, he saw [REDACTED] and [REDACTED] verbally arguing. The bus arrived and he, [REDACTED] and [REDACTED] entered the bus. [REDACTED] and [REDACTED] continued arguing on the bus. [REDACTED] continued to argue and then he jumped up and went over to [REDACTED] and started to hit her. He got up out of his seat and went over to [REDACTED] to pull him away from [REDACTED] in an effort to stop the fight. In the process of pulling [REDACTED] away he spun [REDACTED] around and this is when he was stabbed with a pair of scissors in the left biceps by [REDACTED].

I met with Bus Driver Natasha Rogers and she told me the following: She heard students fighting at the back of the bus and attempted to calm them down. She contacted SDPBC Transportation Department when [REDACTED] came to the front of the bus and showed her the stab wound to his arm. She then told [REDACTED] to come to the front of the bus. She then waited for Law Enforcement to arrive.

They continued to argue on the bus. [REDACTED] got up and hit [REDACTED] and they started to fight. [REDACTED] then pulled out a pair of scissors and cut [REDACTED]

I met with JFKMS student and bus # 0208 passenger [REDACTED] (DOB: [REDACTED]) and he told me the following: He was waiting at the bus stop for his bus. He heard from other students waiting at the bus stop that [REDACTED] and [REDACTED] wanted to fight. 
