## SUBJECT: RELEASE OF FY2012 FCAT WRITING RESULTS: ALL STUDENTS TESTED

On May 18, 2012, the Florida Department of Education (FDOE) released the FY2012 FCAT Writing results for all students tested.<sup>1</sup> In February of 2012, a total of 38,148 students took FCAT Writing in the School District of Palm Beach County (SDPBC) at grades 4, 8, and 10.

An analysis of the FY2012 FCAT Writing results in Table 1 revealed the following major finding:

• In FY2012, the SDPBC outperformed Florida at all tested grade levels in the percentage of students scoring 3 or higher.

We have focused our analysis on the FY2012 results for students scoring 3 or higher. In FY2012, the number of scorers, the prompt types, and the accountability measures<sup>2</sup> are different than in previous years. Additionally, in FY2012, the FDOE applied more stringent scoring methods. This included an increased emphasis on the correct use of standard English conventions, such as sentence structure, mechanics, usage, punctuation and spelling, and attention to the quality of details requiring use of relevant, logical, and plausible support.

As a result of changes in FY2012, there were unexpected and unprecedented drops in the percentage of students scoring 4 or higher<sup>3</sup> (with the drops ranging from 33 to 54 percentage points), making comparisons to previous years inappropriate. Recognizing this, on May 15, 2012, the Florida State Board of Education held an emergency meeting to adopt a new performance level standard for FCAT Writing. The performance level standard used for the purpose of calculating school grades for FY2012 will be a 3.0 on a scale of 6.0. The emergency rule awards credit to schools towards their school grades based upon the percentage of students scoring 3.0 or higher instead of 4.0 or higher on FCAT Writing.
