TO:PrincipalsFROM:David W. Christiansen, Ed.D., Deputy Superintendent/Chief of SchoolsSUBJECT:FY17 RESULTS OF THE TEACHER/STAFF SCHOOL EFFECTIVENESS QUESTIONNAIRE

The District administered the School Effectiveness Questionnaire (SEQ) from January to February 2017. The SEQ measures perceptions regarding the effectiveness of our District schools.¹ For FY17, the District administered the Teacher/Staff version online for the seventh year.² The SEQ provides important information to schools and the District to develop and sustain a Positive and Supportive School Climate, which is a central theme in the Strategic Plan. The categories for the SEQ were developed from the results of a factor analysis and a review of national school climate surveys.³ The categories in the SEQ are: Instructional Leadership, High Expectations, School Climate, Decision Making, and Student Conduct.

A review of the FY17 Teacher/Staff SEQ results reveal the following:

Response Rates

- The FY17 response rate for the District (68%) was significantly⁴ higher than FY16 (54%).
- From FY16 to FY17, response rates at:
 - Elementary schools increased from 57% to 74%;
 - Middle schools increased from 49% to 59%;
 - High schools increased from 51% to 63%.

¹ In FY2011, a sixteen-member committee of school and central-office administrators revised the SEQ after a review of national school climate surveys and the District's need for more information related to issues affecting our schools.

² The District used a third-party purveyor to administer the teacher/staff version in order to reduce costs and ensure anonymity of respondents.

³ Survey items that are highly inter-correlated or loaded more closely together are supposed to measure the same construct or conceptual category. The average of these item responses composed a category score. This allows the categories to have statistical support. Category labels were taken from research literature related to the structure of school climate.

⁴ The significant difference is determined based on the statistical Test of Independent Proportions (TIP).

Percent Positive Responses

The percent positive responses are comprised of those responses on the SEQ Likert scales that denote agreement (strongly, moderately, or slightly agree), the extent of influence for decision making (moderate influence or a great deal of influence), or the degree of concern for student conduct (where adverse conduct is a minor problem or not a problem).

From FY16 to FY17, the percent of positive responses showed:

- An overeall increase from 80% to 85%,
- Significant increases in the categories of Instructional Leadership, High Expectations, School Climate, Decision Making and Student Conduct.
