SUBJECT: FY2016 RESULTS OF THE TEACHER/STAFF SCHOOL EFFECTIVENESS QUESTIONNAIRE

The School District of Palm Beach County (the District) administered the School Effectiveness Questionnaire (SEQ) from January to April 2016. The SEQ measures perceptions regarding the effectiveness of our District schools. For FY2016, the District administered the Teacher/Staff version online for the sixth year. The categories for the SEQ were developed from the results of a factor analysis and a review of national school climate surveys. In the Teacher/Staff version these categories were: Instructional Leadership, High Expectations, School Climate, Decision Making, and Student Conduct. A review of the FY2016 Teacher/Staff SEQ results revealed the following:

Response Rates

- The FY2016 response rates at the elementary, middle and high school levels were significantly lower than those for FY2015 (see Table 1).
- From FY2015 to FY2016, response rates at:
 - o Elementary schools decreased from 71% to 57%;
 - o Middle schools decreased from 59% to 49%;
 - o High schools decreased from 63% to 51%.

Percent Positive Responses

• For FY2016, the District's overall percent positive responses for the Teacher/Staff version of the SEQ remained the same as that of FY2015 (80%) and similar to that of FY2014 (81%) (see Table 2).

¹ In FY2011, a sixteen-member committee of school and central-office administrators revised the SEQ after a review of national school climate surveys and the District's need for more information related to issues affecting our schools.

² The District used a third-party purveyor to administer the teacher/staff version in order to reduce costs and ensure anonymity of respondents.

³ Survey items that are highly inter-correlated or loaded more closely together are supposed to measure the same construct or conceptual category. The average of these item responses composed a category score. This allows the categories to have statistical support. Category labels were taken from research literature related to the structure of school climate.

⁴ The significance is determined based on the statistical Test of Independent Proportions (TIP).

District Percent Positive Responses

The percent positive responses are comprised of those responses on the SEQ Likert scales that denote agreement (strongly, moderately, or slightly agree), the extent of influence for decision making (moderate influence or a great deal of influence), or the degree of concern for student conduct (where adverse conduct is a minor problem or not a problem). In FY2016, the District's percent positive response for the Teacher/Staff version of the SEQ was 79.6% overall. The percent positive responses for FY2016 were similar to FY2015 and FY2014 for most of the categories. A comparison of the District percent positive responses for the past three years (FY2014-FY2016) follows.
