MIDDLE SCHOOL PROMOTION REQUIREMENTS

To be promoted, middle school students must pass Language Arts, Mathematics, Science and Social Studies.

GRADE AVERAGE FOR MIDDLE SCHOOLS

To receive a passing final grade in a year-long course, students must earn a Quality Point Average of at least 1.0 (A=4, B=3, C=2, D=1, F=0).

CUMULATIVE GRADE POINT AVERAGE (GPA)

Cumulative GPA is the overall GPA for all credits attempted except for those replaced through the district forgiveness policy. A Cumulative GPA of at least a 2.0 is required for graduation.

STATE ASSESSMENT REQUIREMENT FOR HIGH SCHOOL GRADUATION

Students must achieve a passing score on the Grade 10 English Language Arts assessment and pass the Algebra I EOC exam in order to receive a standard diploma. Students who fail to achieve a passing score may retake the test during subsequent scheduled test administrations.

EOC COURSES

Students enrolled in an EOC course (Algebra I, Biology I, Geometry, U.S. History and M/J Civics) are required to take a standardized, statewide End-of-Course (EOC) Assessment. Statute requires the district to weight the assessment as thirty percent (30%) of the student's final course grade. Grades will not be calculated and credit will not be awarded until the end of the school year (high school credit courses only). Students who do not take the EOC will earn an I in the course until the EOC is taken and results are included in the grade.

Final grades for high school credit courses will be calculated as follows:

Coursework will count as seventy percent (70%) of a student's final grade. The coursework portion of the grade will be comprised of each of the four quarter grades counting as twenty-two percent (22%) and the midterm exam counting as twelve percent (12%). The EOC will count as thirty percent (30%) of the final grade.

Final grades for Civics will be calculated as follows: Average of the four marking periods seventy percent (70%), plus EOC thirty percent (30%).

The EOC grading scale is:

- Level 5 = A
- Level 4 = A
- Level 3 = B
- Level 2 = C
- Level 1 = D

Note that a Level 3 or above is required on the Algebra I EOC for high school graduation.

COMMUNITY SERVICE

Students earning the 24 credit standard diploma must complete at least 20 hours of community service during high school in order to graduate. Questions should be directed to your school counselor.
