FDOE Value-added Model (VAM)

- Contribution to a change in a student's achievement on standardized test
- Calculated from a statistical measure of student learning growth


What is the **Expected** Score?

- Gifted status
- Class size
- Student Attendance (Days)
- Mobility (number of transitions)
- Difference from modal age in grade (indicator of retention)
- Number of subject-relevant courses enrolled
- Homogeneity of entering test scores in the class
- Students with Disabilities (SWD) status
- English Language Learner (LY) status
