RULE TITLE: Wellness Promotion Policy; RULE NUMBER: Policy 2.035.

SUBJECT AREA TO BE ADDRESSED: Public comment and questions regarding the expansion of scope and/or changes of wellness policy provisions contained in Policy 2.035 and its incorporated Wellness Promotion Goals and Objectives, which implement the Healthy, Hunger-Free Act of 2010.

PURPOSE AND EFFECT: To bring additional stakeholders into the development, implementation, and review of the School District's local wellness policy. Further, the local school wellness policy is an important tool for parents, local educational agencies, and school districts in promoting student wellness and academic success.
