The School District of Palm Beach County offers a seamless integration of Advocacy and Employee Assistance Program (EAP) + Work/Life services to employees, spouses/domestic partners, dependent children, parents, and parents-in-law at no additional cost to you. The District offers the Advocacy programs through Health Advocate which is headquartered in suburban Philadelphia, and the EAP + Work/Life through a division of Health Advocate, located in Jacksonville, Florida.

#### **Executive Summary for the Programs**

Advocacy, EAP + Work/Life are key benefits in the overall offering to the employees and families of the District.

One of the goals that we embarked on in the 2017-2018 school year was to look for new ways to infuse communications throughout the year to continue to promote the programs. The overall interactions in 2017 increased to 16,573 where we saw 13,222 in 2016.

Employee Assistance/Work Life and Specialty Care Locators were the strongest drivers to the program in 2017. Claims assistance is third with Benefits Education fourth, to round out the top 4 top call drivers throughout the year.

Health Advocate continues to partner in health and wellness fairs, Wellness Champion meetings, ongoing communications and webinars, new employee orientations and ongoing onsite training sessions. We attended EAP/Advisory Committee Meetings where we reviewed trends, best practices, and new ideas for EAP and Advocacy promotion with a cross-section representation of the District. During this last school year, Health Advocate added an increased focus on the Advocacy benefit by speaking about it during Wellness Champion meetings and partnering with the Risk and Benefits Management team to create additional custom communications (home mailing and custom flyers). We attended the Heart and Sole bash and provided a Chair Massage therapist for the event.

Special awareness flyers were sent on Heart Health, Financial Fitness, Colorectal Cancer, Alcohol Abuse, Mental Health, Mother's/Father's Day, Summer Safety, Suicide Prevention, Breast Cancer, Domestic Violence, Pre-Diabetes, Hand washing Awareness, and Holiday Stress.

#### **Advocacy Utilization - Clinical**

Health Advocate provided assistance with 1,589 clinical interactions last school year. 47% of the calls were driven by Specialty Care locator needs. The 2<sup>nd</sup> and 3<sup>rd</sup> call drivers were Care Coordination (8%) and Health Information (6%).

### **Advocacy Utilization – Administrative**

Health Advocate provided assistance with 1,454 interactions last school year 46% of the calls were driven by Claims Assistance needs. The 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> call drivers were Benefits Education (18%), Compass (16%), and "Appeals Assistance" (11%).

Overall, Health Advocate has spent 1,333 hours resolving issues for members and their families in 2017, helping to relieve the stress of having to deal with complex medical issues on their own and keeping them focused and productive. In addition, we have saved the members over \$31,000 from resolving billing issues and the District nearly \$200,000 in productivity savings.

### **EAP + Work / Life Utilization**

Health Advocate provided over 6,925 hours of service in 2017 for the District employees and their families. Health Advocate continues to make a significant impact through more than 3,200 employees accessing onsite support, training and personal growth.

The top 3 reasons for utilizing the EAP were Emotional, Family, and Anxiety. Stress and Relationship round out the top 5. Of the cases that were handled with the counselors, 77% were handled by the EAP team. The additional cases were coordinated with various other resources (i.e. legal assistance, outpatient mental health, financial, community resources, etc.).
